A BILL FOR AN ACT

RELATING TO THE SPECIAL ACTION TEAM ON AFFORDABLE RENTAL HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to address the
- 2 special action team on affordable rental housing created under
- 3 Act 127, Session Laws of Hawaii 2016.
- 4 More specifically, this Act expands the membership of the
- 5 special action team to include the executive director of the
- 6 Hawaii community development authority and executive director of
- 7 the Hawaii public housing authority. The Hawaii community
- 8 development authority has jurisdiction over areas conducive to
- 9 the development of affordable rental housing. The Hawaii public
- 10 housing authority has jurisdiction over and the mission to
- 11 provide affordable rental housing for low-income families and
- 12 individuals.
- 13 The legislature finds that the inclusion of both officers
- 14 on the special action team on affordable rental housing is
- 15 necessary and appropriate.

18		president of the senate;
19	[(5)]	(7) A representative from each county, to be
20		appointed by the mayor of the respective county;

1	$[\frac{(6)}{(8)}]$ A member of the public to represent affordable
2	housing advocacy groups, to be appointed by the
3	governor;

6	be appointed by the governor; and
7	$[\frac{(8)}{(10)}]$ A member of the public to represent for-profit
8	developers with expertise in housing development, to
9	be appointed by the governor."

11	and stricken. New statutory material is underscored.
12	SECTION 4. This Act shall take effect on July 1, 2017.
