# A BILL FOR AN ACT

RELATING TO THE SPECIAL ACTION TEAM ON AFFORDABLE RENTAL HOUSING.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to address the
special action team on affordable rental housing created under
Act 127, Session Laws of Hawaii 2016.

4 More specifically, this Act expands the membership of the 5 special action team to include the executive director of the 6 Hawaii community development authority and executive director of 7 the Hawaii public housing authority. The Hawaii community 8 development authority has jurisdiction over areas conducive to 9 the development of affordable rental housing. The Hawaii public 10 housing authority has jurisdiction over and the mission to 11 provide affordable rental housing for low-income families and 12 individuals.

13 The legislature finds that the inclusion of both officers 14 on the special action team on affordable rental housing is 15 necessary and appropriate.
