### A BILL FOR AN ACT

RELATING TO OFFENSES AGAINST PROPERTY RIGHTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that vandalism to
- 2 restroom facilities in public parks is occurring more
- 3 frequently, at the expense of the enjoyment of these public
- 4 parks by the general public. For example, at Sandy Beach park
- 5 one of the sinks in the men's bathroom was torn out of the wall,
- 6 and drains, urinal valves, and toilet paper dispensers were
- 7 broken. A nearby trash container was burned. Vandals also
- 8 struck the recreation center at Makakilo community park by
- 9 painting profanity-laced graffiti on the exterior of the
- 10 building.
- 11 Vandals have also destroyed public restrooms at Kahuku
- 12 district park, where park staff discovered a destroyed sink,
- 13 toilet, and urinal in the men's bathroom. Police are also
- 14 looking for the person who destroyed a toilet and burned the
- 15 toilet paper dispenser in the men's bathroom at Whitmore
- 16 neighborhood park. Vandals also painted graffiti on restrooms,
- 17 playground equipment, sidewalks, and community buildings at



- 1 Crestview community park in Waipahu. In addition, vandals
- 2 destroyed a bathroom at Keehi lagoon, torched portable toilets
- 3 at Kaiaka beach park, and smashed a toilet at Ala Moana beach
- 4 park.
- 5 The legislature finds that such destruction costs taxpayers
- 6 money but also prevents people from using and enjoying public
- 7 parks.
- 8 The purpose of this Act is to create the offense of
- 9 criminal property damage of a public restroom.
- 10 SECTION 2. Chapter 708, Hawaii Revised Statutes, is
- 11 amended by adding a new section to part III to be appropriately
- 12 designated and to read as follows:
- 13 "§708- Criminal property damage to a public restroom.
- 14 (1) A person commits the offense of criminal property damage to
- 15 a public restroom if the person intentionally or knowingly:
- 16 (a) Damages a toilet, urinal, bathroom stall, mirror, or
- sink so as to render it unusable; or
- (b) Sets fire to a trash receptacle,
- 19 at a public restroom.
- 20 (2) Criminal property damage to a public restroom is a
- 21 misdemeanor; provided that notwithstanding sections 706-640 and

- 2 public restroom shall be subject to a minimum fine of \$
- 3 and shall be subject to a minimum term of imprisonment of
- 4 months not to exceed the maximum term of imprisonment under
- 5 section 706-663.
- 6 (3) For purposes of this section, a public restroom means
- 7 any restroom or comfort station located at a public park or
- 8 recreational ground, as that term is defined in section 708-
- 9 814.5."
- 10 SECTION 3. This Act does not affect rights and duties that
- 11 matured, penalties that were incurred, and proceedings that were
- 12 begun before its effective date.
- 13 SECTION 4. New statutory material is underscored.

14 SECTION 5. This Act shall take effect upon its approval.
