1 (e) Distributing commercial messages through any electronic communication system, including but not 2 3 limited to the Internet. 4 "Escort" means any person who provides company to other persons for amusement, companionship, or entertainment at any 5 6 public or private location in exchange for a fee; provided that 7 the term shall not include companionship services for the aged 8 or infirm under section 387-1. 9 "Intimate areas" has the same meaning as in section 10 711-1111. 11 "Massage therapist" has the same meaning as in section 12 452-1. 13 "Massage therapy" has the same meaning as in section 452-1. 14 "Relaxation therapist" means any person who engages in the 15 occupation or practice of relaxation therapy for compensation. 16 "Relaxation therapy" means any method of practicing healing 17 arts other than massage therapy, including but not limited to pedicure, manicure, reflexology, and spa treatment services." 18 19 SECTION 3. This Act does not affect rights and duties that 20 matured, penalties that were incurred, and proceedings that were 21 begun before its effective date.
