A BILL FOR AN ACT

RELATING TO CONTRACTORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that electrical
- 2 contractors are responsible for managing the technical aspects
- 3 of electrical work. The legislature also finds that electrical
- 4 work may pose hazards related to public and worker safety.
- 5 Therefore, individuals and entities applying to be licensed as
- 6 electrical contractors and electronic systems contractors should
- 7 demonstrate the necessary level of training and knowledge to
- 8 possess a trade license to perform electrical work in accordance
- 9 with chapter 448E, Hawaii Revised Statutes.
- 10 The purpose of this Act is to protect the public and
- 11 promote worker safety by requiring electrical contractors and
- 12 electronic systems contractors to possess a trade license to
- 13 perform electrical work in Hawaii or an electrical engineering
- 14 degree from a duly accredited collège.
- 15 SECTION 2. Chapter 444, Hawaii Revised Statutes, is
- 16 amended by adding a new section to be appropriately designated
- 17 and to read as follows:

Requires any person applying for a license as an electrical contractor or electronic systems contractor, except pole and line contractors or high voltage electrical contractors, to possess a trade license or an electrical engineering degree from an accredited college to perform electrical work in the State.
