A BILL FOR AN ACT

RELATING TO CONTRACTORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that electrical
- 2 contractors are responsible for managing the technical aspects
- 3 of electrical work. The legislature also finds that electrical
- 4 work may pose hazards related to public and worker safety.
- 5 Therefore, individuals and entities applying to be licensed as
- 6 electrical contractors should demonstrate the necessary level of
- 7 training and knowledge to possess a trade license to perform
- 8 electrical work in accordance with chapter 448E, Hawaii Revised
- 9 Statutes.
- The purpose of this Act is to protect the public and
- 11 promote worker safety by requiring electrical contractors to
- 12 possess a trade license to perform electrical work in Hawaii or
- 13 an electrical engineering degree from a duly accredited college.
- 14 SECTION 2. Chapter 444, Hawaii Revised Statutes, is
- 15 amended by adding a new section to be appropriately designated
- 16 and to read as follows:

1 "§444- Licensing of electrical contractors and 2 electronic systems contractors; minimum qualifications. (a) 3 Effective July 1, 2017, any person applying for a license as an 4 electrical contractor shall possess, at a minimum, a journey 5 worker electrician license pursuant to chapter 448E, or an 6 electrical engineering degree from a duly accredited college. 7 (b) Effective July 1, 2017, any person applying for a license as an electronic systems contractor shall possess, at a 8 minimum, a journey worker specialty electrician license pursuant 9 10 to chapter 448E, or an electrical engineering degree from a duly 11 accredited college. (c) A public utility or a community antennae television 12 company shall be exempt from this section; provided that the 13 public utility is located within the State and operating under a 14 15 franchise or charter granted by the State." SECTION 3. Section 444-11.1, Hawaii Revised Statutes, is 16 17 amended to read as follows:

"§444-11.1 Requirements to maintain license. (a)

- (d) Failure to restore a license within sixty days after
- 2 the date of forfeiture shall result in the forfeiture of all
- 3 fees and shall require the person to apply as a new applicant.
- 4 (e) The board may assess a fee not to exceed \$1,000,
- 5 impose a bond, or restrict the license as a condition for the
- 6 restoration of a license forfeited pursuant to this section.
- 7 (f) A licensee may, within sixty days after receipt of the
- 8 notification of the forfeiture, request an administrative
- 9 hearing to review the forfeiture pursuant to chapter 91.
- 10 (g) Effective July 1, 2017, in addition to the
- 11 requirements set forth in this section, electrical contractors
- 12 and electronic systems contractors who are licensed under this
- 13 chapter shall meet the requirements of section 444- ."
- 14 SECTION 4. Nothing in this Act shall be construed to
- 15 prohibit a general contractor from performing customary duct or
- 16 conduit work as part of site preparation.
- 17 SECTION 5. New statutory material is underscored.
- 18 SECTION 6. This Act shall take effect on July 1, 2050.
