BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there are state laws that regulate pesticides. The legislature further finds that 2 providing an increased cost threshold will allow the department 3 4 of agriculture to maintain consistent funding in the State's 5 efforts to provide pesticide regulation with informed and educated studies. The purpose of this Act is to increase the pesticide use 7 8 revolving fund threshold amount in order to allow the department 9 to have funds available to carry out its mandate in section 149A-13.5. 10 SECTION 2. Section 149A-13.5, Hawaii Revised Statutes, is 11 amended by amending subsection (e) to read as follows: 12 All unobligated, unencumbered, or unexpended 13 14 funds remaining in the fund in excess of [\$250,000] \$1,000,000 at the close of each fiscal year shall lapse to 15 the state general fund." 16
