Authorizes the issuance of a citation for specific violations of beauty culture laws by licensees and permittees. Sets forth a process for licensees and permittees to contest the citation and provides for the assessment of fines for each violation.

A BILL FOR AN ACT RELATING TO CITATIONS FOR BEAUTY CULTURE VIOLATIONS.

PURPOSE: To authorize the issuance of citations to licensees and permittees who violate specific beauty culture laws.

MEANS:

Add a new section to chapter 439, Hawaii Revised Statutes (HRS).

JUSTIFICATION: Citations for unlicensed beauty culture activity are authorized under section 436B-26.5, HRS. Currently, there is no mechanism to issue citations for licensee or permittee conduct that violates chapter 439, HRS. This bill seeks to establish a citation process as an alternative means for the Board of Barbering and Cosmetology (Board) to address specific beauty culture violations.

> The bill also requires personal service of the citation upon the licensee and permittee and affords the licensee and permittee the opportunity to submit a written request for a hearing to contest the citation within twenty calendar days. The bill also provides that failure to pay any assessed fine within thirty calendar days may subject the licensee and permittee to further disciplinary action.

> The citation process created in this bill will expedite enforcement of and promote swift compliance with beauty culture laws. The bill also will allow investigative staff to focus efforts and resources on other beauty culture violations.
