RELATING TO CITATIONS FOR BEAUTY CULTURE VIOLATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 439, Hawaii Revised Statutes, is	
2	amended by	y adding a new section to be appropriately designated	
3	and to rea	ad as follows:	
4	" <u>§43</u> 9	9- Citation for licensee or permittee violations;	
5	fines. (a	a) In addition to any other remedy available under	
6	this chapt	ter, the department may issue a citation to any person	
7	who holds	a beauty operator, beauty instructor, beauty shop, or	
8	beauty school license, or a temporary or beauty apprentice		
9	permit, fo	or any of the following violations of this chapter or	
10	the rules	adopted pursuant to this chapter and chapter 91:	
11	(1)	Failure of a beauty operator, beauty instructor,	
12		beauty shop, beauty school, beauty apprentice, or	
13		temporary permittee engaged in the practice of	
14		cosmetology to display a license or permit in a	
15		conspicuous place in the office, place of business or	
16		employment, or school, during all hours of operation;	
17	(2)	Failure of a beauty shop owner or beauty school to	
18		ensure that only individuals who hold a current and	

1		appropriate license or permit engage in the practice
2		of cosmetology in the beauty shop or beauty school;
3	(3)	Failure of a beauty shop engaged in the practice of
4		cosmetology to conspicuously display, in all reception
5		and work rooms, a sign that shall read "PRICE LIST
6		AVAILABLE UPON REQUEST" in capital letters at least
7		three-fourths inch in size;
8	(4)	Failure of a beauty school to identify each
9		instructor-trainee at the beauty school during all
10		hours of instruction with a name tag stating
11		"Instructor-trainee";
12	(5)	Failure of a beauty school to identify each instructor
13		at the beauty school during all hours of instruction
14		with a name tag stating "instructor" and identifying
15		the instructor's appropriate beauty operator category;
16	(6)	Failure of a beauty school, during all hours of
17		instruction, to operate the beauty school with an
18		instructor-student ratio of one instructor for every
19		twenty-five students, or with a minimum of two
20		licensed instructors; or

1	(7)	Failure of a beauty school performing work upon or for
2		members of the public to display in a conspicuous
3		place in the reception and work rooms one or more
4		signs at least eighteen inches by twenty-four inches
5		in size that shall read "School of Beauty Culture -
6		Work done by students under supervision".
7	(b)	Each citation:
8	(1)	Shall be in writing and describe the basis of the
9		citation, including the specific statute or rule
10		violated;
11	(2)	May contain an order of abatement and the assessment
12		of a fine in the amount of \$100 for each violation;
13	(3)	Shall be served on the licensee or permittee by
14		personal service; and
15	(4)	Shall inform the licensee or permittee that the
16		licensee or permittee may submit a written request to
17		the board or its designee for a hearing to contest the
18		citation, within twenty calendar days from the service
19		of the citation.
20	(c)	If the licensee or permittee timely submits a written
21	request to	o the board or its designee for a hearing, the board

- 1 may designate a hearings officer to conduct the hearing in
- 2 accordance with chapter 91.
- 3 (d) If the licensee or permittee does not timely submit a
- 4 written request to the board or its designee for a hearing, the
- 5 citation shall be deemed a final order of the board.
- 6 (e) Failure of a licensee or permittee to pay any assessed
- 7 fine within thirty calendar days, unless the licensee or
- 8 permittee contests the citation, may result in further
- 9 disciplinary action taken by the board."
- 10 SECTION 2. This Act does not affect rights and duties that
- 11 matured, penalties that were incurred, and proceedings that were
- 12 begun before its effective date.
- 13 SECTION 3. New statutory material is underscored.
- 14 SECTION 4. This Act shall take effect on July 1, 2017.
