"A BILL FOR AN ACT RELATING TO MARINE RESOURCES,"

The purpose of this measure is to require all motorized recreational vessels operating in nearshore waters to observe nowake zones at specified beaches.

The Kailua Neighborhood Board, Ho'omana Pono, LLC., and several individuals testified in support of this measure. Windward Boating Association, Hawaii Goes Fishing, and numerous individuals testified in opposition to this measure. Department of Land and Natural Resources and one individual commented on this measure.

Your Committee has amended this measure by redefining the nowake zone at Kailua, Oahu, to include Lanikai Beach. Technical, nonsubstantive amendments were also made for style, clarity, and consistency.
