Sirs:

Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 491, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT MAKING AN APPROPRIATION TO THE DEPARTMENT OF THE PROSECUTING ATTORNEY OF THE CITY AND COUNTY OF HONOLULU,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to appropriate funds as a grant-in-aid to the Department of the Prosecuting Attorney of the City and County of Honolulu for the Career Criminal Prosecution Unit.

Your Committee on Conference finds that supporting a strong and effective prosecutor's office is vital to protecting the health, safety, and welfare of the public. It has long been a recognized problem that a relatively small number of repeat criminals, or "career criminals", commit a disproportionate number of the serious crimes against the public. For that reason, the Legislature created the career criminal prosecution program in 1979. This program has

been effective in assisting prosecutors' offices in delivering swift and effective justice. Accordingly, it is important to continue to provide funding to the Department of the Prosecuting Attorney of the City and County of Honolulu for its Career Criminal Prosecution Unit so that the department may continue to protect the public from these dangerous career criminals.

Your Committee on Conference has amended this measure by:

- Changing the appropriation amount to \$300,000; and
- (2) Changing the effective date to July 1, 2017.

As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your Committee on Conference is in accord with the intent and purpose of S.B. No. 491, S.D. 1, H.D. 1, as amended herein, and recommends that it pass Final Reading in the form attached hereto as S.B. No. 491, S.D. 1, H.D. 1, C.D. 1.
