The purpose of this measure is to:


- (1) Address renewable energy tax incentives by replacing the current income tax credit for renewable energy technology systems with tax credits for solar energy or wind property and energy storage property; and
- (2) Establish and appropriate funds for a building energy efficiency demonstration project within the Department of Transportation to set building energy efficiency standards that assist the State in reaching net zero emissions.

The Distributed Energy Resources Council, Ulupono Initiative, Green Charge, and Stem, Inc. supported this measure.
