Your Committee on Finance, to which was referred S.B. No. 683, S.D. 2, H.D. 1, entitled:

"A BILL FOR AN ACT PROPOSING AMENDMENTS TO ARTICLES VII AND X OF THE CONSTITUTION OF THE STATE OF HAWAII TO AUTHORIZE THE LEGISLATURE TO ESTABLISH A SURCHARGE ON RESIDENTIAL INVESTMENT PROPERTY AND VISITOR ACCOMMODATIONS TO INCREASE FUNDING FOR PUBLIC EDUCATION, "

begs leave to report as follows:

The purpose of this measure is to propose amendments to Articles VII and X of the Constitution of the State of Hawaii to authorize the Legislature to establish a surcharge on residential investment property and visitor accommodations to advance the State's goal of providing a public education for the children of Hawaii.

Testimony in support of this measure was received from the Board of Education, Hawaii Teacher Standards Board, Hawaii Women's Coalition, Hawaii Public Charter Schools Network, Hawaii State Teachers Association, Democratic Party of Hawaii, Parents for Public Schools of Hawaii, IMUAlliance, Hui for Excellence in Education, Americans for Democratic Action, Hawaii Alliance for Progressive Action, and numerous individuals.
