Your Committee has amended this measure by:

- (1) Changing its effective date to July 1, 2090, to promote further discussion; and
- (2) Making technical, nonsubstantive, amendments for clarity, consistency, and style.

requiring the Hawaii State Fusion Center director appointee to have expertise and experience in fields that relate to the position.
