Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 997, S.D. 1, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO THE UNIFORM CONTROLLED SUBSTANCES ACT, "

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to update Hawaii's Uniform Controlled Substances Act by adding several new substances scheduled in the federal controlled substances law or emergency scheduled by the Department of Public Safety.

Your Committee on Conference finds that this measure makes Hawaii's Uniform Controlled Substances Act under chapter 329, Hawaii Revised Statutes, consistent with changes to federal law and emergency scheduling by the Department of Public Safety. Committee on Conference further finds that the updates made in this

Your Committee on Conference has amended this measure by:

- (1) Making it effective upon its approval; and
