"SENATE CONCURRENT RESOLUTION REQUESTING THE DEVELOPMENT OF A COLLABORATIVE PLAN TO BEST LEVERAGE STATE AND COUNTY FUNDS TO BUILD AFFORDABLE HOUSING PROJECTS AND AN EXPLORATION OF THE FEASIBILITY OF TRANSFERRING A PARCEL OF LAND IN KAHULUI, MAUI, TO THE HAWAII HOUSING FINANCE AND DEVELOPMENT CORPORATION,"

- (2) HHFDC, the Department of Accounting and General Services, and the County of Maui to work together to explore the feasibility of transferring a parcel of land

at 153 West Kaahumanu Avenue in Kahului, Tax Map Key No. 370040030000, to HHFDC to develop a mixed-use rental housing project.
