Your Committee on Ways and Means, to which was referred S.R. No. 33 entitled:

"SENATE RESOLUTION REQUESTING THE OFFICE OF HAWAIIAN AFFAIRS TO CONVENE A TASK FORCE OF HAWAIIAN LEADERS, LEGAL SCHOLARS, AND A BROAD REPRESENTATION OF MEMBERS OF THE HAWAIIAN COMMUNITY TO REVIEW AND CONSIDER WHETHER ITS FIDUCIARY DUTY TO BETTER THE CONDITIONS OF HAWAIIANS AND MANAGE ITS RESOURCES TO MEET THE NEEDS OF HAWAIIAN BENEFICIARIES WOULD BE BETTER SERVED BY HAVING TRUSTEES APPOINTED RATHER THAN ELECTED, "

begs leave to report as follows:

The purpose and intent of this measure is to request the Office of Hawaiian Affairs (OHA) to convene a group of Hawaiian leaders, legal scholars, and Hawaiian community members to:

- Review whether the manner of selecting and seating OHA (1) trustees could be improved through a process by which trustees are appointed rather than elected;
- (2) Consider the appropriate appointing authority; and
- Consider how to develop a list of the best qualified (3) potential trustees for submittal to the appointing authority.
