| HB 499 Status | RELATING TO THE PRESCHOOL OPEN DOORS PROGRAM. | <u>HB 500</u> <u>Status</u> | RELATING TO PUBLIC PREKINDERGARTEN PROGRAMS. Requires the executive office on early learning to enter into a memorandum of understanding with the Hawaii state public charter school commission to administer charter school prekindergarten classrooms. Appropriates moneys to continue funding of public prekindergarten classrooms. | EDN, FIN |
