RELATING TO BEHAVIOR ANALYSIS SERVICES.

HLT, CPC

Clarifies certain elements of the behavior analyst law, including: clarifying the definition of "practice of behavior analysis"; clarifying the individuals who may implement behavior analysis services, including individuals who are supervised by a licensed professional working within that licensed professional's recognized scope of practice, when that scope of practice overlaps with the practice of behavior analysis; and exempting caregivers from the licensure requirements for behavior analysts. Effective 7/1/2050. (SD1)
