<u>HB 914</u> <u>Status</u>	RELATING TO HEALTH INSURANCE. Requires a health carrier with a network plan to maintain a network that is sufficient in numbers with appropriate types of providers to ensure that covered persons have access to covered services.	HLT, CPC, FIN
<u>HB 248</u> <u>Status</u>	RELATING TO HEALTH INSURANCE. Requires all health insurers, including health benefits plans under chapter 87A, HRS, to disclose on their public web sites any standards, criteria, or information used for making preauthorization decisions.	HLT, CPC, FIN
<u>HB 156</u> <u>Status</u>	RELATING TO REIMBURSEMENT OF PHARMACISTS. Requires insurers, mutual and fraternal benefit societies, and health maintenance organizations to recognize services provided by pharmacists.	HLT, CPC, FIN
<u>HB 1406</u> <u>Status</u>	RELATING TO THE PRACTICE OF PHARMACY. Amends the definition of "practice of pharmacy."	HLT, JUD
<u>HB 1444</u> <u>Status</u>	RELATING TO PHARMACY BENEFIT MANAGERS. Requires pharmacy benefit managers to register with the insurance commissioner.	HLT, CPC
<u>HB 676</u> <u>Status</u>	RELATING TO HEALTH. Authorizes pharmacists to prescribe and administer the human papillomavirus vaccine to persons between eleven and seventeen years of age. Specifies requirements pharmacists must meet prior to administering the human papillomavirus vaccine.	HLT, CPC
<u>HB 1299</u> <u>Status</u>	RELATING TO HEALTH. Authorizes a pharmacy to provide a customized patient medication package to any patient of an institutional facility or any member of the general public, subject to certain conditions.	HLT, JUD, FIN



DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.

Submit testimony in ONE of the following ways:
