SB 141 Status & Testimony	RELATING TO PHYSICIAN WORKFORCE ASSESSMENT. Allows the John A. Burns School of Medicine to continue to receive a portion of the physician workforce assessment fee for ongoing physician workforce assessment and planning to support the recruitment and retention of physicians in the State, particularly those in rural and medically underserved areas.	HRE/CPH, WAM
SB 730 Status & Testimony	RELATING TO HEALTH. Creates the global primary care training program to combine the Hilo medical center primary care training program and the University of Hawaii family medicine residency program on Oahu so that the two programs collaborate and allow residents from each program to intern with the other.	HRE/CPH, WAM
SB 735 Status & Testimony	RELATING TO THE HAWAII HEALTH CORPS PROGRAM. Appropriates funds for the implementation and administration of the Hawaii health corps program that provides loan repayment for physicians, physician assistants, nurse practitioners, psychologists, and social workers who agree to work in a federally designated health professional shortage area or an area of Hawaii found to be underserved.	HRE/CPH, WAM
SB 1164 Status & Testimony	RELATING TO THE UNIVERSITY OF HAWAII. Appropriates moneys for the University of Hawaii to hire three psychologists and one case manager to provide student mental health services.	HRE/CPH, WAM
