Amends the income withholding requirements to impose a fine against any employer who discharges from employment, refuses to employ, or takes disciplinary action against any noncustodial parent subject to income withholding, or who fails to comply with an order of assignment of future income. <u>SB 964, SD1</u> ( <u>SSCR886)</u> <u>Status</u>	RELATING TO HOMELESS SHELTERS. Establishes that emergency shelters may provide partitioned space for homeless persons or families based upon guidelines determined by the department of human services. Extends the effective date for Act 234, Session Laws of Hawaii 2016, by one year. Takes effect June 30, 2017. (SD1)	HUS, JUD, FIN
