RELATING TO CHILD CARE PROVIDERS.

Beginning January 1, 2019, requires child care providers licensed or registered by the department of human services to obtain and maintain

liability insurance coverage. Takes effect 7/1/2050. (SD2)

SB 748, SD1

(SSCR734) Status

RELATING TO CHILD CARE FACILITIES.

Requires the department of human services to post its inspection records of child care facilities that involve substantiated complaints on a public website and submit an annual report to the legislature of

certain information from inspection records related to child care facilities. Appropriates funds to the department of human services for the posting of child care facility inspection records and an annual

report to the legislature. (SD1)
