<u>SB 1016, SD1</u> (SSCR853) <u>Status</u>	RELATING TO TRANSPORTATION. Temporarily exempts the Department of Transportation and its contractors from certain state requirements for certain bridge rehabilitation projects by extending the end date to June 30, 2022. Effective 6/29/17. (SD1)	TRN, FIN
<u>SB 658, SD2</u> (SSCR875) Status	RELATING TO AN AIRPORT CORPORATION. Authorizes the establishment of the Hawaii airport corporation within the department of transportation for administrative purposes on July 1, 2018. Sets out appointment of members to the board of directors and powers and duties of the Hawaii airport corporation. Transfers the aeronautics functions of DOT to the Hawaii airport authority. Effective 12/16/2066. (SD2)	TRN, LAB, FIN
<u>SB 420, SD1</u> (SSCR637) <u>Status</u>	RELATING TO LASER DEVICES. Makes it a criminal offense to intentionally or knowingly direct the beam from a laser or laser scope at an occupied aircraft under certain circumstances. Takes effect on 1/7/2059. (SD1)	TRN, JUD
