<u>HB 715</u> (HSCR343) <u>Status</u>	RELATING TO URBAN AGRICULTURE. Requires the counties to incorporate urban agriculture principles and policies in land use planning and to allow urban agriculture as a residential use in a residentially designated zone.	AGR, WAL
<u>HB 54</u> <u>Status</u>	RELATING TO SMALL BOAT HARBORS. Prohibits the Chairperson of BLNR from adopting any rule with respect to a small boat harbor where a marine fueling station has been established that requires the exclusive fueling of vessels from that station only.	WAL
<u>HB 117, HD2</u> (HSCR508) Status	RELATING TO MARINE RESOURCES. Requires all motorized recreational vessels operating in nearshore waters to observe no-wake zones at specified beaches. (HB117 HD2)	OMH, WAL
HB 329 Status	RELATING TO LAND USE. Allows counties to submit their general plans to LUC for review and to request land use boundary amendments in conformance with those plans.	WAL
