Dear Chair Tokuda, Vice Chair Dela Cruz and Committee Members:

My name is Brandon Elefante and I am in **strong support** to appoint Mr. Damien Elefante as Deputy Director of the Department of Taxation. I am related to Mr. Elefante and have witnessed him display strong credentials both on a personal and professional level. He is more than capable to lead and serve this department. As a native and long time resident of O'ahu, Mr. Elefante also went on to graduate from Kailua High School, the University of Hawai'i, and Syracuse Law School. Since returning home from law school, he has made a positive impact working in the public sector. He served as a former law clerk for the late Judge Burns, has experience in the private sector, worked in the State Attorney General's Office for over a decade, and now at the Department of Taxation. He has authored and successfully defended the State in a case that went to the United States Supreme Court that raised constitutional challenges (tonnage clause and federal preemption) on the imposition of the general excise tax on gross income received from fishing charters. In addition, he successfully obtained a judgment in the State favor valued at about six million dollars at the Hawaii Tax Appeal Court against national corporations that argued that the use tax is inapplicable on the value of products imported in to Hawaii for resale to the general public pursuant to Baker and Taylor, 103 Haw. 359, 82 P.3d 804 (2004). He handled and wrote the appeal briefs in cases at the Hawaii Supreme Court appealing the Tax Appeal Court's judgments that were unfavorable to the State. He successfully obtained and established case precedents and law in favor of the State concerning the imposition of taxes on the business income of national corporations in Hawaii. Most notably, he is regarded with a high level of integrity, commitment, and is dedicated to serve the people of Hawai'i.

In closing, he still manages to find a balance between his family and professional life as a husband and loving father. I humbly ask this committee for its favorable support of **GM 505** to appoint Mr. Elefante as Deputy Director of the Department of Taxation. Thank you.
