I have had the privilege of appearing before The Honorable Derrick H.M. Chan during his tenure as Probate Court Judge sitting in the First Circuit Court, State of Hawaii, and strongly support his appointment to serve as an Associate Justice on the Intermediate Court of Appeals.

Judge Chan is an exceptional judge and person. When he became Probate Judge in 2010, Judge Chan humbly acknowledged that he was not well-versed in trusts and estates law, but it was clear from the outset that he did his homework, worked diligently, and quickly mastered the applicable statutes, court rules, case law, tax laws, and financial issues that are unique to this practice area. No matter how many cases are on his Thursday calendar, Judge Chan is always prepared, asks pertinent questions, and treats everyone with respect. law. As Chief Judge of the First Circuit, Judge Chan has worked hard to make the Circuit Courts accessible and efficient and was appropriately honored as the 2016 Jurist of the Year.

Although my first-hand experience with Judge Chan has been in Probate Court, Judge Chan has a breadth of legal experience that makes him uniquely qualified to analyze the range of cases that come before the Intermediate Court of Appeals. I write to you in strong support of Judge Derrick H. M. Chan's consideration and confirmation to the Intermediate Court of Appeals. I have had the honor and privilege to appear before Judge Chan almost since I started practicing law. In a sense, I feel like I have "grown up" with him as a judge and myself as an attorney.

I first appeared before Judge Chan as a newly appointed deputy prosecuting attorney. Judge Chan was also newly appointed to the Circuit Court bench and was assigned to the DVM (domestic violence misdemeanor) as well as the misdemeanor jury demand calendars. I tried the majority of my first jury trials before Judge Chan. He was always extremely fair and happy to share his thoughts, post-trial, with all of the counsel who were interested. He would often explain his perspective and offer suggestions on how to approach the issues that came before him.

He served as a mentor to many young trial attorneys, including myself, often sharing his vast experience as a criminal trial attorney. He had a clear command over the rules of evidence and trial procedure. But there was never any ego or superiority attached. He simply wanted to help us become better attorneys.

In the last 5 years, I have appeared before Judge Chan almost exclusively as I focused my practice on probate and trust litigation and conservatorships and guardianships. I have hearings before Judge Chan almost every Thursday and have also attended countless status and settlement conferences with him. I can unequivocally say that he is one of the best judges I have ever worked with.

The most striking thing about Judge Chan is that he has never shied away from difficult cases or hard work. He has been consistently dedicated to making the right decision but also has

a knack for knowing when to let the parties try to work things out on their own, with his assistance. For the probate calendar, just knowing the law is not enough. Equity is supremely important as well for we are often dealing with highly emotional family matters. Judge Chan's even-tempered nature in the midst of often highly emotional situations has helped to resolve many cases. It is also significant that he puts the same effort into cases involving hundreds of millions of dollars as those with little to no resources. The number of zeroes has had no bearing on his desire to get to the right result. I have had rulings for and against my clients, and I always felt that each case was looked at fairly.

Judge Chan did not hesitate when I asked him to talk to high school students on a career day. He sat and explained his path on becoming a judge. They were so impressed by all that he has accomplished and I am continually impressed with all he has contributed to the bench and to the bar. I have no doubt he will continue to contribute his time to educating future generations.

While we will miss his presence in probate court, we will all benefit from having him serve in the appellate court. I have no doubt that his decisions will be just as consistent in their thoughtfulness and fairness to all litigants. For these reasons I strongly support his confirmation.

Thank you for the opportunity to testify in support of GM 506, relating to the appointment of Judge Derrek H. M. Chan as Associate Judge of the Hawaii Intermediate Court of Appeals.

My name is Oren T. Chikamoto. I am an attorney licensed to practice law in this State. I was admitted to the Hawaii Bar in 1973 and the focus of my practice since then has been in the areas of tax, estate planning and the settlement and administration of trusts and estates.

During the last 9 years I have had the distinct privilege of appearing before Judge Chan in all of my probate and trust cases.

My very first case before Judge Chan was in September of 2009 which involved the probate and settlement of a decedent who had died many years earlier. This was very shortly after Judge Chan was appointed as the new Probate Judge. The issue before Judge Chan in my probate case was whether decedent's Will (which at this point was being asked to be admitted to probate more than 5 years after decedent's death) could be admitted as decedent's last Will. As Judge Chan had previously been handling criminal case I had reservations as to his knowledge of probate law and estate matters generally.

My concerns and reservations were without basis. In this and subsequent cases I have found Judge Chan to be smart and a very fast learner, fair, decisive, courteous and a very good listener. These qualities together with his piercing ability to reduce sometimes highly emotional, complex factual and legal issues to their basic components and apply them in a sensible and practical manner have in my opinion made him one of our better judges who have sat on the probate bench; better still, qualities that I have every confidence will make him a good appellate judge and now a valuable addition to the appellate bench.

I, therefore, support and urge this committee to confirm the appointment of Judge Derrek H. M. Chan as Associate Judge of the Hawaii Intermediate Court of Appeals.

I do not believe anyone would express a negative comment about his temperament and his demeanor in the courtroom.
