Dear Senate Judiciary and Labor Committee:

This testimony is in support of the nomination of Keith Hiraoka to the Circuit Court bench.

To give some basis for my position, I respectfully submit a little bit of background. I started my legal career by serving as a law clerk to the late William S. Richardson, when he was Chief Justice of the Hawaii Supreme Court. I began practice in 1973, served my profession as President of the Hawaii State Bar Association in 1997, the as Bar Association Delegate to the House of Delegates of the American Bar Association, then Hawaii State Delegate to the ABA, for 9 years. I currently serve on the ABA Board of Governors of a 4-state district, including Hawaii.

I have known Keith for more than 20 years. We both began our careers as general litigators, he more on the defense side, I more on the plaintiffs side, and we both moved into litigation practices with focuses on insurance coverage and bad faith litigation. His practice approximates 50%, mine 90%, of that field.

I came to know him well by appearing on panels at seminars on Insurance litigation topics – he on the insurer side, I on the policyholder/plaintiff side. We did that for years.

In spite of the fact that we are on the opposing sides of the litigation spectrum, I have always admired his professionalism, intellectual acuity, generous and accepting nature (though able to be tough as nails when he needs to), and humble confidence.

This is to respectfully request that the Senate Committee on Judiciary and Labor confirm the appointment of gubernatorial nominee Keith K. Hiraoka as a Judge of the Circuit Court of the First Circuit, State of Hawai`i.

I first met Keith in the early 1980's when he began working at the law firm then known as Case, Kay & Lynch. I am an attorney with a substantial practice involving insurance law. I have been involved in numerous claims with Keith Hiraoka beginning in the 1980s through the present in both the State and Federal courts. These have included cases litigated through the State Supreme Court and the Federal Ninth Circuit Court of Appeals. I have personal knowledge of Keith's professional competence, integrity and personality based on 30+ years of working with him – usually as opposing counsel.

Keith Hiraoka has established a reputation as one of the leading lawyers in Hawaii in the areas of civil litigation and insurance disputes. My experience working with him has been that Keith practices with the highest level of legal knowledge and competence. I have no reservation in saying that he is one of the best in our field. Mr. Chair and Members of the Committee:

I am writing in strong support for the appointment of Keith Hiraoka to the First Circuit Court of the State of Hawaii.

I first became acquainted with Attorney Keith Hiraoka 10 years ago. I didn't know him at all, but one day, out of the blue, he called me at work. He called just as I arrived to work after dropping my youngest daughter off on her first day of school. He asked me if I was Zelda's mom. I replied that I am. He told me that she looked to be in tears sitting outside the classroom before school started, so he asked a little girl named Cassidy to sit next to and take care of Zelda, and be her friend for the day. Cassidy and Zelda became best friends that year. What Keith did was so touching to me. He is the type of person who would go out of his way to help others whenever he could. It was an unforgettable moment for me, and soon, thereafter, we became good friends.

As a colleague, and working on cases with and against his firm, I have known him to be intelligent, diligent, responsible, and professional. He has many years of private practice experience and knowledge in many areas of the law. These are all the characteristics and background experience necessary for an outstanding judge.

But, to me, one of the most important things in being an outstanding judge is that the judge needs to be "fair" and "unbiased" – to be able to fairly decide who is right and who is wrong. I know from personal experience that Keith will preside over cases with impartiality.

Keith volunteered to be a HYSA soccer referee on the weekends. Senators:

I write in enthusiastic support of the nomination of Keith Hiraoka as a judge of the First Circuit Court, State of Hawaii. I would appear in person before the committee but will not be in the state on the day his hearing is scheduled.

First the basics. Keith is a professional colleague of long standing. He is not a personal friend. I have never socialized with him. I am a non-partisan in terms of political affiliation. I have never been a registered member of either party and have never worked on behalf of any candidate, including Governor Ige. I have been a licensed attorney in Honolulu for 40 years. My practice has always been 100% civil litigation. I have appeared before more judges than I can count, some excellent, some good and some not so good. I have tried well over 100 jury trials to verdict. I have appeared in every trial division of every Circuit Court and in the Federal Court. I have an AV pre-eminent rating by Martindale-Hubbell from both the bar and the judiciary. Based upon my background and experience I think I can recognize someone who will be a superior judge. I can say, without qualification, that in my opinion Keith Hiraoka will make a superior circuit court judge.

Over the years I have been involved in many, many lawsuits in which Mr. Hiraoka was also counsel. I have also been involved in conferences and ADR with him. Sometimes we have been representing parties whose interests were aligned. In other cases our parties were adverse to each other. Mr. Hiraoka knows litigation, backward and forward. He knows the law and knows the rules. He knows how a courtroom should be run and should not be run. I have no doubt that any person or attorney who appears before him will get a full and fair hearing, will have an opportunity to present his or her case but will not be permitted to waste the limited resources of the court unnecessarily. Decisions by Judge Hiraoka will be grounded in law and supported by facts. They will be explained where explanation is needed. When explanation is necessary it will be delivered well.

Over the past several years Mr. Hiraoka's practice has emphasized insurance coverage. That is a difficult, complex and often contentious area of law. It requires both intellect and good analytical skills. Mr. Hiraoka has exhibited both qualities repeatedly. My own practice also involves insurance coverage from time to time. Mr. Hiraoka is one of only two attorney who I will call for advise when I have a question or am uncertain about a matter. These instances are great examples of his likely "judicial temperament". On several occasions he has expressed an opinion that I did not "like" or "want". I have argued with him (judicial temperament is not a quality anyone has ever said I have). Invariably he will calmly explain the bases for his opinion and/or repeat the central focus of his reasoning. I have never had him raise his voice or cut me off, even when I probably deserved it. In the same vein I have seen him argue in court on many occasions on behalf of his client. I have NEVER seen him be disrespectful in any way or act inappropriate in any way toward a party, opposing counsel or the court.

In closing I will note that I have from time to time commented on judicial candidates since the time practicing attorneys were permitted/encouraged to do so. More often than not my comments have been critical or cautionary. I can honestly say with regard to Mr. Hiraoka that I cannot think of a better qualified candidate for a Circuit Court judgeship.

- Appointment of a three-person review Subcommittee of HSBA Board members by the President, which serves as a neutral fact-finding body to review documentation submitted by the nominee, contact references submitted by the nominee, review comments received from the HSBA membership, and conduct follow-up member contact for clarification, if necessary, for presentation to the HSBA Board.
- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.
