Per request from your office, I respectfully submit my answers as follow:

1. Why do you want to be a member of the Board?

Answer – I believe my education, employment and personal background make me a wellsuited candidate for the Board. As we all know Hawaii is one of the most culturally diverse states and has one of the highest proportions of non-English speakers in the nation. Presently I am a licensed attorney in Hawaii and am currently employed as a limited English Proficiency (LEP) Project Manager at the Hawaii Department of Human Services. I am responsible for overseeing and managing the development and implementation of department-wide systems, programs, policies and procedures designed to address the language needs for the Department's LEP applicants and clients. I am also originally from Thailand and once spoke very limited English. This experience has truly inspired me to help other limited English speakers who face similar situations when trying to access basic human needs. If I were selected to be a member of the board, I believe I would be able to provide useful, current insight about the state of language access programs inHawaii.

2. What do you perceive are the roles and responsibilities of a member of the Board?

Answer – As mandated by the Statute, **I** will serve in an advisory capacity to the executive director of the Office of Language Access. I will be providing input on implementation and compliance with the Language Access Law; the quality of oral and written services; and the adequacy of a state agency or covered entity's dissemination and training of its employees likely to have contact with limited English proficient persons, its policies and procedures for language services, its competency in working effectively with in-person and telephone interpreters, and its understanding of the dynamics of interpretation between clients, providers, and interpreters.

3. In what ways do you feel that you can help protect the consumer?

Answer – As a representative from the state government, I am always working to protect

the interests of the public. In my role as a Limited English Proficient Project Manager I am always working to make sure that the consumer, in this case the LEP individual, is protected. The very nature of my job is to make sure that one of the most vulnerable consumers in Hawaii, the LEP individual has access to government programs and services. That said, Ialso balance the needs of the LEP individual with the budget that I am given. I regularly assess the status and effectiveness of current language access efforts. It is my job to identify program deficiencies and create corresponding solutions to provide the best services to LEP individuals within a budget. To do this, I regularly evaluate the effectiveness of different types of interpreting resources and advise the director about alternatives available to improve the access to services for LEP individuals. I am therefore very knowledgeable about the language access tools currently available to the consumer.

4. Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I believe that I am qualified to be a member of the Board due to my experience as both a Limited English Proficient Project Manager and Coordinator at the Department of Human Services. I think I am especially well-suited to provide the Board with input on language access topics because I have worked tirelessly to increase language access for LEP individuals by managing the development and implementation of department-wide systems, programs, policies and procedures designed to address the language needs of those individuals so that they may be better served by the Department. In doing so, I have also been able to collaborate with other state departments and private sector partners to establish and coordinate the implementation of a comprehensive department's efforts to increase language access to clients, which has provided me with a great deal of knowledge in the tools available to improve the access to services for LEP applicants and clients. While my work has focused mainly on increasing language access to the Department of Human Services clients, I believe that the programs that I have implemented and continue to manage allows me to provide valuable input to the Board.

5. What do you hope to accomplish during your term of service?

As an advisory member, I want to ensure that language will not be a barrier to accessing any state programs or services. While I am passionate about and work on increasing language access every day, I realize that not everyone values language access the same way. I hope that I will be able to provide insight so that all entities will have a better understanding about language access law and will take reasonable steps to ensure persons with limited English proficiency gain meaningful access to their services, programs, and activities.

6. Name three qualities that best describe you and how these qualities will benefit the Board.

My education, employment and personal background make me a well-suited candidate for this

position. As a lawyer, an advocate for LEP individuals and an immigrant - someone who has faced a language barrier head-on, I have first-hand knowledge of the obstacles LEP individuals face as well as an awareness of the tools available to overcome those obstacles. I believe this would make me a valuable addition to the Language Access Advisory Council.

7. Name a previous experience you've had that will be beneficial as a Board member.

<u>Answer</u> – As a Limited English Proficiency (LEP) Project Manager at the Hawaii Department of Human Services, I am responsible for overseeing and managing the development and implementation of department-wide systems, programs, policies and procedures designed to address the language needs for the Department's LEP applicants and clients. This experience has given me first-hand knowledge of all of the tools available to increase language access. Because I also have experience working with these tools, I am also able to provide insight to what tools work best for different situations and different types of clients and the best practices to make sure that each tool is being implemented properly.

8. Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

<u>Answer</u> – I believe that there will be no conflicts of interest during my service on the Language Access Advisory Council. However, if there is a situation that presents a potential conflict of interest, I will immediately consult with the Hawaii State Ethics Commission.
