I was asked to join the board by other current members from Adult Mental Health and the Family Guidance Center while interfacing at a County Community Coalition on Drug Treatment/Integration, Prevention and Enforcement to represent the Substance Abuse/ Addiction perspective of our community's needs ... the Kauai Service Area Board for Mental Health and Substance Abuse did not have a community provider representatives to represent Substance Abuse treatment

(2) What do you perceive are the roles and responsibilities of a member of the Board?
