#### Barbara Yamashita

#### 1. Why do you want to be a member of the Board?

Throughout my career, in human services and public health, I have taken an interest in the life course—birth through death. I have had the privilege to work within communities and believe that the aging population presents a valuable resource to communities—especially to those communities that want to be more resilient. I think the "resource" value of the aging population has long been overlooked or devalued. While I believe that the needs of our aging population must be addressed—the focus should include how we capture the value and expertise of this segment of the population. I would like to support the efforts currently being addressed by the executive office on aging (EOA) and advocate for also including the view of the aging population as a community resource.

#### 2. What do you perceive are the roles and responsibilities of a member of the Board?

The HRS is clear about the purpose of the Policy Advisory Board for Elder Affairs (PABEA)— Identification of issues and alternative approaches to solutions; the development of position statements and papers; advocacy and legislative action; and program development and operations.

#### 3. In what ways do you feel that you can help protect the consumer?

I believe that by supporting and helping the agency be effective in what they do and they fulfill the mandates of that office—both at the state level as well as the expectations of the federal mandates—that helps consumers. Hawaii has populations that live long and we (collectively as a community) need to ensure that the needs of our aging population are addressed. We need to look at the health needs, social needs, emotional needs and economic needs of our aging population and ensure a comprehensive approach in setting policy and programs.

# 4. Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

My career has been in health and human services. I have had the privilege of working in a small rural community as administrator of Molokai hospital, public health, Medicaid and the "business" of health, chronic disease and disaster or emergency response. All of these areas require that the issues be addressed in an age appropriate manner as well as a cultural and community based appropriate approach. I feel honored that I have had the opportunity to work in a broad arena that allowed me to learn and address issues in tailored ways to address specific needs. I believe in data informed decision making and evaluation and am very comfortable in areas that encourage community based participation.

#### 5. What do you hope to accomplish during your term of service?

To serve well—to listen and to help translate need and help with formulating approaches to address those needs.

### 6. Name three qualities that best describe you and how these qualities will benefit the Board.

I believe in (1) community-based participation. I am comfortable with (2) data informed approaches and like to read about (3) best practices and innovation across the globe. I believe that internationally there are exciting things happening to address the broad needs of our aging population—from productive aging to meeting the needs of those who are in need of long term care.

#### 7. Name a previous experience you've had that will be beneficial as a Board member.

I was Chief of the Community Health Division, which focused on community engagement in program development and design. I also believe that working in a small rural community has been a valuable learning experience. It is difficult to isolate experience and the knowledge gained. Honestly, all my experience will help to serve on PABEA.

### 8. Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

I am retired and do not believe that this will be an issue.
