HAWAII PAROLING AUTHORITY IN SUPPORT OF

GOVERNOR'S MESSAGE 537

Aloha mai ka kou! Mahalo for the opportunity to appear before you today. I have been fortunate to have served as interim chairman of the Hawaii Paroling Authority since August of 2016. I thank Governor Ige for that opportunity and his nomination to continue serving as Chairman, working with everyone in Hawaii's Criminal Justice System and our community. I also wish to thank the current parole board members and HPA staff for their support and mentoring. Words cannot express how much their experience and assistance has helped me. Also, the late Renwick "Uncle Joe" Tassill, Aunty June and members of the Holomua Pu'uhonua group who keep me grounded. Lastly, I wish to thank my wife and children and my parents for their support and understanding (and why I'm not at home as much as I used to be).

I come before this Committee ready to work and continue to address the initiatives and problems facing our prison and paroled populations. Henry Ford said *"If you always do what you've always done, you'll always get what you always got."* We need change. The current board is a balanced board with a wide range of experience that helps me to promote change. Change for a WIN-WIN. Win for PSD/Corrections, Inmates, the Community and the HPA.

- Hawaii Administrative Rules (23-700-31 (b)) says once parole is denied, a hearing must be held within 11 months and that's what was **DONE**. Now the **CHANGE**,
 - The board now schedules hearings in 3, 4, 6, 8, 9 months as well as 11. It increases the number of hearings but the board is willing to do this in the interest of everyone. FY16, the board held 4,689 hearings. At the current rate since October 2016 we are projecting the number of hearings to exceed 5,100.
 - Denying parole isn't always a bad thing. It also means time to finish programs to be parole eligible. Time to save more money before you go out in the community or pay restitution. Time to secure appropriate residence or acceptance to a program.
- Hearings are not a "slam-dunk". It requires, review, study, listening, feeling and yes time. Despite the number of in person hearings, the board will host an average of 20 in person hearings a day.

• Contrary to popular belief, hearings are not all about release. There are violations, reconsiderations and minimums to hear and rule on.

The responsibilities of the Chairman go beyond presiding over hearings. It is about education and preparing the community for the eventual release. *"Lock um up and throw away the key."* We have heard this all too often. Yes, there are inmates who have to be controlled by confinement, but the greater majority of convicted felons will one day be released either by acquittals, parole or maxing out (end of sentence). It is unfortunate when inmates "max out" with no treatment or resocialization efforts. If we throw away the key, it means as a society and community we've given up. No hope. As parents, do we give up on our children? If we threw away the key, how many talented and community minded people would not be here in our presence today nor blessed us with their gifts (and taxes)? I cannot emphasize enough the risk and danger of locking up someone for 5,10, 20 years or more without program, treatment, education and expect them to be law abiding citizens with no risk to our community.

Chair Nishihara, Vice Chair Wakai, and Members of the Committee:

The Department of Public Safety (PSD) **strongly supports** the nomination of Edmund (Fred) Hyun as the Chairperson of the Hawaii Paroling Authority (HPA), for a term to expire June 30, 2020.

Since his appointment as Chairperson of the HPA on August 1, 2016 to the present, Mr. Hyun has overseen 1,898 Parole Hearings. This is notable for an eight (8) month period, with 69 offenders being immediately paroled and another 496 paroled soon after hearing with added support services.

Aloha Chair Nishihara, Vice-Chair Wakai, and members of the Senate Committee on PSM, my name is Stephen Morse. I am the Executive Director of Blueprint for Change (BFC) and am here today to support the confirmation of Fred Hyun as Chairperson of the Hawaii Paroling Authority.

Members, for the record, BFC is the fiscal, technical, and administrative support entity for seven Neighborhood Place centers statewide that provide support and strengthening services to families at risk of child abuse and neglect under a POS contract with the Department of Human Services. The several varied risk factors in the families, including homelessness or unstable housing, unemployment and low incomes, substance abuse, chronic health problems, parental incarceration, and physical disabilities.

Since July of 2015, I have had the honor of serving with Fred on an ad hoc Advisory Group called, Holomua Pu`uhonua (moving forward with Pu`uhonua), that was formed by the late Uncle Joe Tassill, a former Hawaiian Homes Commissioner, at the urging of Governor David Ige. The group was formed to explore ways in which a Pu`uhonua System (a Hawaiian Wellness System) could be established in Hawaii as stipulated in Act 117, Session Laws of Hawaii 2012. Besides Fred and I, the group was comprised of representatives from the Department of Public Safety, other service providers, ex-offenders, Hawaiian Kupuna, and former children of incarcerated parents.

From the very beginning of our group's discussions, I was impressed by Fred's wealth of knowledge and experience in working in Hawaii's corrections and social services systems. With a unique blend of compassion combined with a realistic approach to problem-solving, he brought an amazing amount of substance and clarity to our discussions. His input was critical in the working group's ability to identify the key planning elements that were needed as next steps in implementing Act 117. With this data, BFC was able to help the group secure funding from the Office of Hawaiian Affairs and the federal Administration for Native Americans to develop two projects related to the implementation of Pu`uhonua System. The OHA grant has given us the opportunity to develop a Strategic Plan for a Pu`uhonua System throughout the State, while the ANA funding is allowing us to develop a Hawaiian value-based training program that will serve as a core program of the Pu`uhonua System and help Native Hawaiian offenders and exoffenders become, "E Ho`okanaka," persons of worth, by reconnecting them to their cultural roots, practices, and principles.

We believe Fred has brought that same kind of cultural understanding and compassion blended with realism to his work as the Interim Chairperson of the HPA during his tenure there. With this unique combination of knowledge, experience, and skills, we firmly believe that Fred will be a strong asset in assisting parolees to successfully reintegrate into the community and prevent the recidivism that has plagued our criminal justice system. We strongly support his confirmation.
