He is also a past President of the General Contractors Association of Hawaii (2006); member of the 2009 Construction Taskforce established by the Hawaii State Legislature; and was the 2011 Recipient of the Outstanding Union Builder Award from the Hawaii Carpenters' Union. He also serves as a management trustee of Hawaii Masons and Plasterers Training Fund. The responsibility of the trustees is to ensure that the training program properly prepares apprentices as they enter the workforce.

He has also served on the boards of directors of local community organizations.
