(1) Why do you want to be a member of the Board?

I would like to continue serving on the Board of Pharmacy for another term. During my first term, I learned a great deal about the laws and rules of the practice of pharmacy. There were also a tremendous amount to learn about the process of interpreting the laws and rules as well as the work involved in making changes. I would like to continue another term so that I can continue to work on updating the rules so they are clear, concise and up-to-date with the changing practice of pharmacy.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

As a member of the Board of Pharmacy, the most important responsibility I have is to protect the public. Whenever there is discussion on a regulation or application, we must always remember that public safety and protection are our first priority.

(3) In what ways do you feel that you can help protect the consumer?

I feel I can help protect the consumer by always reminding myself about my role as a member of the Board. When discussing whether or not to support proposed legislation or changes to rules, I think I have the values to make the sound decisions and recommendations.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I believe it is extremely important for public safety.

The three qualities that describe me are: amiable, respectful and driven. I think these qualities help me understand the views of others. I believe it is important to prepare for meetings and take a lot of time making sure that I understand the laws and rules and possible applications of them. These characteristics also allow me to voice my opinion in a professional manner.

(7) Name a previous experience you've had that will be beneficial as a Board member.

In December 2016, I had the opportunity to take part in the NABP member forum. During this day and a half conference, I learned a lot about the laws and rules of other states, problems they might have experienced with the changing practice and progress they are making.
