My name is Lee Ann Teshima and I am the Executive Officer for the Board of

Pharmacy ("Board"), Department of Commerce and Consumer Affairs ("Department").

The Department thanks you for the opportunity to testify on Governor's Message

No. 706, regarding the **reappointment** of Mary Jo Keefe to the Board. The Department

supports the confirmation of Ms. Keefe's reappointment to the Board.

Since her appointment in July 2013, Ms. Keefe has attended 33 of the 38 Board meetings scheduled. Ms. Keefe represents Maui County and has been a licensed registered pharmacist in Hawaii since August 1996. Her license is current, active and in good standing.

As Mary Jo Keefe is applying to be reappointed to the Hawaii Board of Pharmacy, I am thrilled to provide a letter of reference for your review.

I have worked directly with Mary Jo for the last 21 years in both retail and long term care (LTC) pharmacy practice and have been her immediate supervisor for the last 19 years. She has a very strong knowledge base in both practice settings developed during the 45 years she has been a licensed pharmacist. Included in her skill sets are sterile and non-sterile compounding – both of which are the true art of pharmacy practice and are currently in the national spotlight; however, she is the only current Board member with these expertise. Over the last 4 years as a Board member she has expanded her knowledge in these areas as the Board's representative at the FDA compounding forum in Washington DC in 2016, inspector training at the National Association of Boards of Pharmacy (NABP) in Chicago in 2015, three of the NABPs annual meetings, and two of the NABP district meetings.

As Maui's most recent Board of Pharmacy representative, serving two terms and the last 3 years as the Chair, I understand the issues that are facing public safety within Hawaii's practice of pharmacy: expanding pharmacist roles in healthcare, pressure from business to stretch pharmacist and pharmacy staff to maintain profit margins, and increasing need to compound medications as shortages from manufactures expand. I have had conversations with Mary Jo regarding these and other important aspects of pharmacy and am confident that she is the right person to continue to represent Maui on the Hawaii Board of Pharmacy.

### GM706 Mary Jo Keefe: Board of Pharmacy

#### (1) Why do you want to be a member of the Board?

I have been a member of the Board of Pharmacy for the past 4 years and have enjoyed being part of the developments in my profession. I look forward to another 4 years, the changes to come, and helping to formulate those changes.

# (2) What do you perceive are the roles and responsibilities of a member of the Board?

#### (3) In what ways do you feel that you can help protect the consumer?

The Board of Pharmacy's main concern is the safety of the people of the State of Hawaii. This includes making sure the drugs that come into the state are not counterfeit or adulterated; that drugs are available to our patients; and that our patients have access to the best care our pharmacists can give. It is also important that our laws and rules reflect the most current standard of care practices. Another concert of the Board is to field questions from people in and out of the state to assure that they are aware of the correct interpretation of the law.

#### (4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I am currently a member of the Board of Pharmacy, serving as the representative from Maui, and am in my 4<sup>th</sup> year as a member. As a member, I have gained much experience in my position. I have been a registered pharmacist for 45 years in Michigan and 35 years in Hawaii. I have experience in the retail and long term care settings, as well as, in compounding (I am the only one on the Board with this background). I am an avid reader of pharmaceutical journals which keeps me up to date on current issues, and I complete over 100 hours a year of continuing pharmacy education.

#### (5) What do you hope to accomplish during your term of service

I hope to continue working on the issues the Board is dealing with now. For example, prescribing pharmacists, regulating pharmacy technicians, collaborative agreements, updating the rules to reflect current practices, regulating compounding pharmacies, and keeping the law test required by new pharmacists coming into the state current.

Dependable- I attend the meetings regularly and am an active participant in discussions and activities.

Volunteer- I am willing to do other things than just attend meetings, I have attended 3 NABP conventions, 2 district meetings, 1 compounding meeting at the FDA, and 1 sterile compounding meeting in Chicago.
