TESTIMONY ON GOVERNOR'S MESSAGE 761 CONSIDERATION AND CONFIRMATION OF SANDRA JOY EASTLACK TO THE CRIME VICTIM COMPENSATION COMMISSION

Good afternoon Chair Nishihara, Vice Chair Wakai, and members of Senate Committee on Public Safety, Intergovernmental, and Military Affairs.

Thank you for providing the Crime Victim Compensation Commission (the "Commission") with the opportunity to testify in <u>strong support of Governor's</u> <u>Message 761, appointing Sandra Eastlack to the Crime Victim Compensation</u> <u>Commission Board</u>.

The Commission was established in 1967 to mitigate the suffering and financial impact experienced by victims of violent crime by providing compensation to pay un-reimbursed crime-related expenses. In 2003, the Commission initiated the Restitution Recovery Program to serve as the clearinghouse for restitution payments collected from inmates and parolees.

The Commission is a quasi-judicial body that assists victims of violent crime by providing compensation for crime-related expenses. The Commission also administers a Restitution Recovery Project for the Justice Reinvestment Initiative to collect restitution from inmates and parolees and disburse the collected funds to crime victims. Commissioners hear appeals from administrative decisions ordering

or denying compensation and set policy for the determination of claims submitted to the Commission. Special areas of concern in the past have been the treatment of sexual assault and domestic abuse victims and enhancing the delivery of compensation services to underserved victim populations, while an ongoing concern remains the sustainable fiscal self-sufficiency of the Commission. The Commission's core mission is solely funded through special funds and federal matching VOCA funds.

Victims of violent crime who apply for compensation are often traumatized and angry about what has happened to them and frustrated about the way the criminal justice system treats victims. Commissioners must be knowledgeable about the impact of violent crime on individuals and be sensitive and compassionate in dealing with these individuals.

The Commission believes that Ms. Eastlack is highly qualified to be a Commissioner. From 2002 to 2004, Ms. Eastlack ably served on the Commission's Board. She understands the Commission's mandate and the needs of crime victims who are often still dealing with the trauma of their victimization.

Her twenty-eight years of experience serving the public and victims of sexual assault and domestic violence will help to inform her decisions as a Commission member. Her education and experience as a counselor for survivors of domestic violence and sexual assault provides a desired understanding of victim needs. In addition to providing direct services to victims, she served on boards and task forces addressing domestic violence. All of these experiences will be invaluable to the Commission in its efforts to provide high quality services to Hawai`i's violent crime victims
