GOVERNOR'S MESSAGE 762 – SUBMITTED FOR CONSIDERATION AND CONFIRMATION TO THE KAHOOLAWE ISLAND RESERVE COMMISSION, **GUBERNATORIAL NOMINEE HÖKÜLANI HOLT-PADILLA**

Governor's Message No. 762 nominates Hokūlani Holt-Padilla to serve on the Kaho`olawe Island Reserve Commission (KIRC) in the seat reserved for a representative of a Native Hawaiian Organization. On behalf of the Commission, I wish to express my strong support and recommend her confirmation.

Ms. Holt's involvement with the protection and restoration of Kaho'olawe began with the Protect Kaho`olawe Ohana (PKO), where she dedicated her time and effort to help with the movement to return Kaho`olawe to the State of Hawaii, brought students from Nā Pua No`eau Center for Gifted and Talented Native Hawaiian Children to Kaho'olawe and founded and dedicated a traditional hula pā in Hakioawa. It was through her hula training and traditions that many hula practitioners and students have been to Kaho`olawe to learn about its importance to Hawaii.

Later, Ms. Holt continued her support of Kaho`olawe as the Cultural and Education Manager for the KIRC during the Navy's cleanup of the island. Through her foundational knowledge and expertise in Hawaiian cultural practices that she was able to develop the orientation program that sensitized the many workers, who were a part of the cleanup, to the importance of Kaho`olawe's place in Hawaii's history and the special nature of the island to the people of Hawaii. She was instrumental in introducing Hawaiian cultural practices as part of the everyday life of the KIRC and educated KIRC staff in the many finer points of caring for an island that is an important symbol to future of native Hawaiian Sovereignty. Ms. Holt is currently the Director of Ka Hikina o Ka Lā, a specialized program at the University of Hawaii Maui College funded by the National Science Foundation that integrates native Hawaiian cultural knowledge and practices into modern scientific technology and instruction.



Commissioner Holt has been serving as a member of the KIRC since her appointment on October 22, 2013. Since that time, Commissioner Holt has taken on the role of guiding and expanding the cultural use of the Reserve.

Commissioner Holt's dedication to perpetuating native Hawaiian culture is in alignment with the KIRC's vision for Kaho'olawe; "where the people of Hawai'i cares for the land in a manner which recognizes the island and ocean of *Kanaloa* (an ancient name for Kaho'olawe) as a living spiritual entity. Kanaloa is a *pu'uhonua* (place of safety) and *wahi pana* (storied place) where Native Hawaiian cultural practices flourish."
