I am writing to strongly support Christine Kili Namau'u's nomination to the Board of Education to represent Maui.

I have known Kili since 1993, when she started as Kahu/Director of Pūnana Leo o Maui. She immediately saw the importance of her staff having a solid foundation of child development knowledge as well as Hawaiian language, and sent her staff to early childhood education (ECE) classes at then Maui Community College. She set an example by also attending ECE classes. Kili's vision was not only a positive impact for Maui, but for the whole state as the other Pūnana Leo sites followed her example. She pursued her own professional development by earning her Master's in Education with Early Childhood Education emphasis.

Kili has had a continued emphasis on continuous quality improvement for her program. Pünana Leo o Maui was the first language immersion (and the only) early childhood education program to be accredited by the National Association for the Education of Young Children (NAEYC). The program is also accredited by the World Indigenous Nations Higher Education Consortium (WINHEC). NAEYC accreditation recognizes the quality early childhood education program, and WINHEC accreditation recognizes the quality language and cultural components of the program.

Kili is a committed community partner. As stated in her resume, she started the "Holo Holo Ka'a" event that is held annually on our campus. It is an event that is anticipated and enjoyed by a wide cross section of our community. Free language classes for the Pūnana Leo 'ohana are open to all. Kili is a regular guest speaker in two of my classes and consistently informs students of the unique aspects of Pūnana Leo and invites students to be engaged in their community activities.

Kili's background, experience, and vision of education will bring an important voice and perspective to the Board. She is a highly valued colleague and friend with a wide network. She is a connector who gets things done. Please contact me if you have any questions.

Her many years of work experience in the Native Hawaiian community, which has provided her with an extensive knowledge of the socio-economic conditions of Native Hawaiians and a thorough understanding of existing policies, programs, and projects established to improve those conditions.

The Council is mindful that Hawai'i operates in a unique context of having a single State Educational Agency (SEA) and Local Educational Agency (LEA); two official languages—English and Hawaiian—that are mediums of instruction in the State's public education system; and a public charter school system that is a blend of Hawaiian language immersion and Hawaiian culture based schools and in the midst of implementing the Every Student Succeeds Act (ESSA)—the most pervasive federal policy change since No Child Left Behind in 2001, returning control to State's by Congressional intent; and working to integrate, holistically and systemically, early learning into our public education system.

The Native Hawaiian Education Council was established in 1994 under the federal Native Hawaiian Education Act. The Council is charged with coordinating, assessing and reporting and making recommendations on the effectiveness of existing education programs for Native Hawaiians, the state of present Native Hawaiian education efforts, and improvements that may be made to existing programs, policies, and procedures to improve the educational attainment of Native Hawaiians.
