GM 776 & 777: Confirmation of Nolan Kawano: Board of Education

Dear Chair Kidani and members of the Committee:

I am submitting testimony in strong support of Mr. Nolan Kawano's nomination to the Board of Education.

During the past six years, I served with Nolan on the board of The Public Schools of Hawaii Foundation. While serving as President, Nolan was a visionary leader who placed a high value on preparing students for an increasingly complex and demanding 21<sup>st</sup> century work environment. As a result of his influence, many of our most innovative Foundation initiatives focus on preparing students for the day when artificial intelligence and robotics will either alter or replace many of the jobs that currently exists today.

For example, Nolan is one of the leaders behind Hawaii's Design Thinking movement. For the past six years, the Foundation has co-sponsored a Design Thinking summer bootcamp because it teaches educators and students how to use human-centered strategies to find creative solutions to wicked problems. In other words, Design Thinking develops human skills involving human empathy, creativity, intuition, collaboration and other human traits that machines do not possess and therefore cannot replace.

In addition, Nolan spearheaded the creation of the Waipahu High Biotechnology Science Scholars Program which is now entering its third year. This groundbreaking program involves a partnership between Rutgers University and Waipahu High School. This partnership allows Waipahu students the opportunity to study the DNA sequence of *Lemnoideae* (duckweed) and its possible medicinal benefits. Student results are published in a scientific journal providing students with the confidence to pursue science careers in medicine or research. It would not surprise me if one day a Waipahu Science Scholars graduate is credited with finding a cure for cancer, diabetes or Alzheimer's disease.

In summary, Nolan is both a visionary and dedicated leader who inspires those around him to do more. Nolan is highly qualified to serve on the Board of Education and I look forward to supporting his efforts in the future. I humbly ask that the committee look favorably upon his nomination.
