My name is Amy Agbayani, chair of the Filipino-American Advocacy Network (FAN) in strong support of Mr. Simeon Acoba Jr. to be reappointed as a Regent of the University of Hawai`i. Regent Acoba was confirmed by the Senate to fill the remainder of a term. During these past two years as a Regent, he has demonstrated his competence, independence and hard work. He has outstanding qualifications and his reappointment is an important affirmation of the importance of diversity for the BOR. Regent Acoba will continue to be a valuable member to fill a full term if confirmed by the Senate.

I have known Mr. Acoba for five decades. I first met Mr. Acoba Fall 1964 when he was an undergraduate political science major and an active ASUH student leader. At the time, I was a new graduate student with the East West Center and we were classmates in a political theory class taught by the iconic professor Allan Saunders. Over the years, I have observed his academic success, his intellectual and legal analysis, his integrity and fair judgments as a member of the judiciary and his service to the community. He has had a very long relationship with UH, first as an undergraduate, as a deputy AG advising the President and the board, lecturer and mentor of many UH law students, interim Regent and proud father of a JABSOM medical graduate. Mr. Acoba and his wife Carolyn continue to share their appreciation of their alma mater by their donation for a scholarship program. UH in turn has acknowledged his contributions to our state and the University by awarding him the UH Foundation Alumni Association Lifetime Achievement Award for 2015.

A few months ago, I retired from UH Manoa after 45 years of service and continue to be active in community affairs. I have had the honor to observe and work with Mr. Acoba on community events relating to civil rights and diversity. I was very pleased that his work was recognized by the Japanese American Citizen's League, one of the leading civil rights groups in Hawai'i and the nation. The state continues to benefit from

workshops and policy recommendations of the Access to Justice Commission, which was founded by Mr. Acoba when he was an Associate Justice of the Supreme Court.

Although I am familiar with Mr. Acoba's public service which impacts many policy areas, Native Hawaiians and all ethnic groups in our state, I will focus my comments on his impact and importance to the Filipino community as a role model for Filipinos and our multicultural community. Regent Acoba was honored by the Filipino Community Center for his public service leadership. I believe it is important for the private sector, the state and the university to meet goals for inclusion and affirmative action to increase representation and success of groups who are under-represented in public and private sector management and policy making boards. I believe representation and diversity in state government is important and results in better policies for our community. Mr. Acoba will add ethnic diversity, his competence and experience to serve the state of Hawai'i and the University. If confirmed, Mr. Acoba and Ms. Doctor Sparks will join current Regent Michelle Tagorda so that 3 of the 15 Regents will be of Filipino ancestry effective July 1, 2017.

The Filipino community has grown since the first immigrants came to Hawai`i in 1906. According to the United States Census, people of Filipino ancestry are the second largest ethnic group in Hawai'i, with fifteen per cent of residents identifying themselves as Filipino alone and twenty five per cent dentifying themselves as Filipino and another race. Students of Filipino ancestry are also the second largest ethnic group in the department of education and represent more than half of the student population at Farrington high school, Waipahu high school, and Lanai high and elementary school. Students of Filipino ancestry are underrepresented in the University of Hawai'i system. Filipino students comprise only thirteen per cent of the entire University of Hawaii system student population. One percent of management/executives, six per cent of the community colleges faculty and two and a half per cent of the University of Hawaii at Manoa faculty are of Filipino ancestry. The seventeen per cent postsecondary degree rate held by Filipinos is significantly lower than Caucasians (42%) and Japanese (35%).

During his brief time as a Regent, Mr. Acoba has demonstrated his, competence, integrity, engagement and dedication to the University of Hawai'i. I am confident that he will continue to be a responsible member of the Board of Regents. I would like to take this opportunity to publicly thank him for being a mentor to many young professionals and for his leadership to improve access to justice and equal opportunity. He has a deep appreciation of the history of UH and our state. I am confident that as a Regent, he will continue to make a positive contribution to the UH and our state. I respectfully ask you to confirm his nomination as a Regent.

The National Justice Center measured the public's accessibility to the Hawaii justice system in four categories: access to lawyers for low-income litigants, the systemic support for effective selfrepresentation, support for members of the public with limited language proficiency, and support of those who were otherwise disabled in some manner that impeded In effect, through Justice Acoba's their ability to gain access to the courts. leadership of and guidance to the Commission, the accomplishments and reputation of the Commission rose to national prominence. His role and contribution to this Commission "opened" the doors of legal services to the those who were historically left out.

My name is Howard K.K. Luke. I am an attorney now in my fortieth year of practice in the State of Hawai'i, and currently the President-Elect of the Hawaii State Bar Association.

I am writing in very strong support of the confirmation of the Hon. Simeon R. Acoba (ret.) to the Board of Regents of the University of Hawai'i. He is an exceptionally great choice for the board, and the university will benefit immensely from his tenure as a regent.

The University of Hawai'i is where Justice Acoba's heart always has been, and always will be. I recall when he and I were both entering freshmen at U.H. in the fall of 1962. He had recently graduated from Farrington High School, and I from McKinley.
