Please find this letter in support of Ms. Norma Doctor Sparks, M.S.W., J.D. as a Regent for the University of Hawaii.

Norma Doctor Sparks, M.S.W., J.D., is Co-founder and President of Families First Hawaii Services Inc., a consulting firm that advocates for children and families. Clients have included the County of Kauai; the Hawaii Department of the Attorney General; and CGI, an international information technology company.

After serving as law clerk for Chief Judge James S. Burns of the Hawaii Intermediate Court of Appeals, Norma was a Hawaii Deputy Attorney General, assigned to the Hawaii Department of Commerce and Consumer Affairs. Prior to law school, she was Administrator of the Family Crisis Services Branch in First Circuit Family Court.

Norma was Administrator of the Hawaii Child Support Enforcement Agency with an annual operating budget of \$12 million and about 300 child support enforcement officers statewide. She increased collections to \$75 million in 1995 from \$48 million in 1991 when her tenure started.

She was Administrator of Child Welfare Services in the Hawaii Department of Human Services with an operating budget of about \$45 million and about 400 staff statewide. She personally identified and obtained over \$9 million in new federal claims each year and over \$3 million in retroactive claims. She also implemented Family Conferencing as one of 5 pioneering jurisdictions in the country.

In California, Norma was Director of the Santa Clara County (Silicon Valley) Department of Family and Children. She managed a budget of about \$220 million and supervised over 1000 staff who provided child welfare services. Within two years of the start of her tenure, she initiated and completed the first successful reorganization of the Department in over 25 years, in close partnership with and support of community-based organizations and four employee union chapters.

She was Deputy Director of the Los Angeles County Department of Children and Families Services where she managed \$200 million and supervised over 1,000 staff. She later was the Administrative Deputy of the Los Angeles County Department of Public Social Services where she managed a \$4 billion budget and services for 14,000 staff.

She received numerous community, federal, state, and county awards in Hawaii and California. In 2007, she was recognized as one of the Top 100 Most Influential Filipina Women in the United States. In 1999, her Hawaii work was recognized by President Clinton and the Child Welfare League of America for most improvement in foster care adoptions.

She has served on community boards including Kauai Planning and Action Alliance; Kauai High School Foundation; Kauai Filipino Chamber of Commerce; Koloa Community Association; and Kauai Filipino Women's Club. She is a member of Kauai Chamber of Commerce; Surfrider Foundation-Kauai; Malama Mahaulepu; Friends of Mahaulepu; and Poipu Beach Rotary Club.

Norma holds a Bachelor of Arts in Sociology, a Master of Social Work; and a Juris Doctorate from the University of Hawaii-Manoa.

She is married to Stephen Sparks and they have two sons, Dr. Chad Sparks of California and Gregory Sparks of New York City.

The Fililipino-American Advocacy Network (FAN) is committed to equal access, non-discrimination and social justice for Filipinos and other groups. As a woman and as a Filipino and co-founder of Operation Manong, I am very proud of the many accomplishments of Norma Doctor Sparks. Decades ago, Ms. Sparks was one of our very first Operation Manong students at UH Manoa. She has excellent qualifications as a lawyer, manager/executive in the public and private sector in Hawai'i and California. Her background, varied experiences, knowledge of Kauai and statewide issues will be an asset to the BOR and the University.

I would like to present one very important dimension for you to consider regarding nominees to state boards. Filipinos and women are severely under-represented in state government cabinet, boards and commissions. Appointing a very competent Filipino woman will add to the diversity of the BOR. Her appointment will be of great benefit to the University and our state. There is good evidence and ethical reasons to support diversity. Programs, decisions and processes are better where there is a diversity of backgrounds, opinions and experiences. Diversity and inclusion should be a compelling and critical beneficial dimension in any organization including public sector decision-making boards and commissions

The US census shows Filipinos are the second largest ethnic/race group in Hawai'i: Filipinos (15% single race and 25% more than one). Although 21% of public school children are Filipino, they are underrepresented at the University of Hawal: 13% of students systemwide, 17% of the Community Colleges students, 10% of undergraduates and 4% graduate students at Manoa, 7% of Hilo students and 21% of West O'ahu students. All campuses have very few Filipino faculty and Filipino focus courses. Filipinos are one percent of UH executives/managers.

As we all know, women hold up half of the sky and are the majority among UH students and on college campuses in the nation. Women faculty continue to be underrepresented at UH and the Board of Regents where there are currently only three of the 15 Regents are women. The perspectives of women are important to include on the BOR.

Our state values diversity and inclusion. It is important to have gender parity and representation of ethnic groups on the BOR. At this time, of the 15 member BOR, there are 3 women and two Filipinos. If the Senate confirms Ms. Sparks then the number of women and Filipinos will increase. I think Ms. Sparks will be the very first Filipino woman to be a Regent since the founding of UH over 100 years ago.

Thank you for this opportunity to express my positive assessment of Ms. Norma Doctor Sparks. Please support her nomination as the Kauai member of the BOR. Norma Doctor Sparks' administrative experience, along with her extensive community service and her commitment to higher education make her an excellent candidate for the Board of Regents. I serve with Norma on the Kauai Filipino Chamber of Commerce Board and have found her to be extremely professional, a team player, an effective communicator and a strong advocate for issues that are important to the Filipino community. In her role as a Regent, I am confident that she will be a strong advocate for Kauai Community College, its programs and its our students. It will be an honor to work with her, and Kauai will be well represented by her.
