

# GM 795 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE COMMISSION ON WATER RESOURCE MANAGEMENT, GUBERNATORIAL NOMINEE, KAMANAMAIKALANI BEAMER, TERM TO EXPIRE 6-30-2021

The Office of Hawaiian Affairs <u>SUPPORTS</u> GM795, which would confirm Dr. Kamanamaikalani Beamer to a second term on the Commission on Water Resource Management (CWRM).

Water's importance to the Native Hawaiian people is captured in the 'ōlelo no'eau "Ola i ka Wai (Water is Life)." Since time immemorial, this precious resource was traditionally considered to be part of the public trust, not to be owned as a private commodity, but to be administered for the common good. Traditional management and assurance of ma uka to ma kai stream flow thus ensured sufficient water for food production, drinking water, healthy estuaries, ground water recharge, and important traditional and customary practices.

Consistent with traditional understanding, the state of Hawai'i recognizes fresh water as a public trust resource for present and future generations. However, in spite of this important designation, the state has in many instances managed our water resources as a commodity, to the detriment of the rights and interests of traditional and customary practitioners, subsistence and small scale farmers, appurtenant right holders, the Department of Hawaiian Home Lands, and domestic users.

For these reasons, CWRM decisions may have direct, long-term impacts on both Native Hawaiians and the larger community. OHA therefore seeks to ensure that CWRM members possess a demonstrated and culturally-grounded respect for the public trust in our water resources, consistent with traditional understandings and values. **Dr. Beamer clearly possesses a deep and culturally-grounded understanding of the need to uphold the public trust in our water resources, and his confirmation to a second term would allow CWRM to continue to benefit from his expertise in Native Hawaiian culture and traditional Hawaiian resource management.** 

Dr. Beamer's extensive background and knowledge of Hawai'i's water resource issues have already proven to be tremendous assets to CWRM, enriching their discussions and decision-making over the last three years. Dr. Beamer is currently an assistant professor in the Hui 'Āina Momona Program at the University of Hawai'i. This program

partners the College of Social Sciences, Hawai'inuiākea School of Hawaiian Knowledge, the William S. Richardson School of Law, and other colleges within the UH Mānoa toward the goal of developing cross-disciplinary solutions to natural and cultural resource management, which includes water management. Dr. Beamer also has accrued on-theground water management experience through his leadership of the 'Āina Ulu Land Legacy Education Initiative with Kamehameha Schools. This ongoing initiative required Dr. Beamer to coordinate 20 community organizations working toward the broad goal of responsible resource stewardship, which includes stewardship over water resources. The initiative provided substantial opportunities for Dr. Beamer to engage in water management across Ka Pae 'Āina in kalo fields, fishponds, and streams. Finally, Dr. Beamer has spent extensive personal time implementing traditional water management techniques, particularly in kalo cultivation.

OHA views Dr. Kamanamaikalani Beamer's nomination for a second term on CWRM as a positive step towards better upholding the State's affirmative obligations to Native Hawaiians and the public trust in water.

Accordingly, OHA urges this Committee to **PASS** GM795. Mahalo for the opportunity to comment on this important measure.

# In consideration of GOVERNOR'S MESSAGE 795 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE COMMISSION ON WATER RESOURCE MANAGEMENT, GUBERNATORIAL NOMINEE, KAMANAMAIKALANI BEAMER, FOR A TERM TO EXPIRE 6-30-2021

The Department of Land and Natural Resources (Department) strongly supports the Governor's nomination of Dr. Kamanamaikalani Beamer to serve on the Commission on Water Resource Management (Commission) for a term to expire 6-30-2021.

The Commission is required under Section 174C-7, Hawaii Revised Statutes, to select commissioners through an open, competitive process. An independent nominating committee composed of two (2) members selected by the Governor, one (1) by the Senate President and one (1) by the House Speaker, solicits candidates typically by placing an ad in the papers across the State, in the monthly bulletin of the Commission, and on the Commission's website. The Nominating Committee reviews the applications, conducts interviews if desired and sends to the Governor the names of at least three individuals for consideration.

The nominees, by law, must have "substantial experience in the area of water resource management."

In accordance with this nominating process, the Governor selected Dr. Kamanamaikalani Beamer.

If confirmed, this will be Dr. Beamer's second term on the Commission, having previously been nominated and confirmed by the 2012 Legislature. In his four years on the Commission, Dr. Beamer has contributed greatly to the thoughtful discussion and resolution of a broad range of water issues facing the Commission, balancing competing interests while determining reasonable and beneficial uses of our precious water resources. He is a passionate advocate for the environment, cultural rights, and public rights in the water resources trust.

Dr. Beamer is currently a professor at the University of Hawaii at Manoa in the Hui Aina Momona Program. He teaches courses and conducts research in the ahupuaa system, water resource management and optimization, and indigenous knowledge related to resource management. Dr. Beamer has published an award-winning book *No Makou Ka Mana* that provides a new perspective on the Mahele and required extensive research of Mahele documents and maps. This area of expertise will be especially valuable as the Commission is in the midst of determining appurtenant rights in Na Wai Eha, Maui.

Previously, Dr. Beamer worked for Kamehameha Schools where he helped twenty-four diverse community groups statewide to restore fishponds, implement best management practices for agriculture and ecosystem health and services, and help communities monitor the work. Dr. Beamer has also been a taro farmer in Waipio Valley and has first-hand knowledge of on-the-ground water resource management practices.

Dr. Beamer's cultural background, work, and academic qualifications bring a wealth of knowledge in traditional water resource management practices and conventional agricultural water systems.

The Department strongly supports Dr. Kamanamaikalani Beamer's nomination and reappointment to the Commission on Water Resource Management.

Please accept this testimony on behalf of KAHEA: The Hawaiian-Environmental Alliance. KAHEA is a Hawai'i-community based 501(c)(3) nonprofit organization with over 10,000 supporters. We are writing <u>in strong support of G.M. No. 795</u>, through which the Governor submitted for consideration and confirmation to the Commission on Water Resource Management, Gubernatorial Nominee, Kamanamaikalani Beamer, for a term to expire June 30, 2021.

Hawai'i greatly benefitted from Dr. Beamer's expertise and decision-making abilities during his first term, which began in 2013. His skills and experience are ideal for any candidate for the Commission seat reserved for persons with knowledge of native Hawaiian traditional and cultural practices. For example, Dr. Beamer brought gravity and strong leadership to a decision concerning whether to issue a considerable fine against Hawaiian lo'i kalo farmers utilizing kuleana lands on Maui for their alleged failure to obtain a Stream Diversion Works Permit. Upon more careful investigation, the Commission found that no such violation occurred. Commissioner Beamer was amongst those who articulated critical questions about whether Hawaiians engaged in the traditional practice of farming lo'i on kuleana lands needed a permit in the first place; sought assurances that such missteps would not occur in the future; and recognized both the costs of time and expense to the farmers who had to fly in from Maui and the complicated task that CWRM staff engages in protecting water resources.

I met Kamana for the first time perhaps a decade ago, and I have worked with him since on the First Nations Futures Program (FNFP) at Stanford and in Hawaii, on the land in Waipio Valley and in Leeward Kohala, on community development in the Kohala Center, and in coauthoring a publication. As part of that work we have made a joint presentation to and workshop with FNFP in which we describe agriculture in Hawaii – both the lo'i system that Kamana has long worked within and the dryland system I'm working on – and its connection to the relationship between people and land, ancestors and ali'i, and also its connection to western ideas of innovation and sustainability. The session is a labor of love for us; I enjoy working with Kamana, more than I enjoy working with any other young scholar anywhere.

The quality of Kamana's scholarship is impressive – which together with his personal qualities makes it a joy to work with him as a collaborator. I read his book No Mākou ka Mana several years ago, and have given it to friends and family members, Hawaiian and Haole, both because of the information it contains and to illustrate the power of indigenous scholarship.

I believe Kamana brings numerous strengths to the Board. His cultural strength is coupled to an understanding of financial realities – he has run a non-profit with a large regional footprint – and with an appreciation for diversity. His success in acquiring land in North Kohala, Kohala Mountain, and the Kuamoo battlefield shows his effectiveness – and I know the process has deepened his appreciation for the value of alliances with a broad range of communities, in moving Hawaii forward. I cannot think of another individual with the combination of strengths and of character that Kamana brings to the Commission.

KUA works to empower their efforts to practice community based natural resource management (CBNRM) to care for land, ocean, and culture primarily through the development and facilitation of networks of practice. My life and Mr. Beamer's have often converged since we first met in the early 2000's as fellow musicians and battered athletes. Aloha Chair Rhoads, Vice Chair Gabbard, and Committee Members,

My name is Jonathan Likeke Scheuer. I was born and raised on the island of O`ahu and have studied and worked on water issues in Hawai`i for over two decades. My past and present work has been significantly focused on the how the CWRM, staff, and other players in water issues interact in the implementation of the 1987 Water Code. I am submitting this testimony as an individual.

As you and your Committee well know, implementation of the Code has been difficult, and multiple Commission decisions have been overturned by the Hawai'i Supreme Court. The Court has repeatedly found the Commission has failed to correctly interpret and implement the law in their decision making. Because of this, financial and human resources have been diverted from taking proactive steps to fulfill the Code's dual mandates of resource protection and use. As water is the critical resource for all people in our islands, the costs of these outcomes should not be overlooked.

Ultimately, this repeated pattern of overturning CWRM decisions has multiple causes. If one seeks to understand this dilemma in order to improve it (rather than to lay blame), it is extremely reasonable to state that there could have been better decisions made by the Commissioners who have served as Trustees of this public trust, the Executive Branch that has a role in appointing Commissioners, and the Senate who must confirm these appointments.

It is for these reasons that the Senate's role in confirmation of appointees to the CWRM is so critical. It is particularly crucial that the Senate consider whether or not the candidates have the affirmative statutory requirement of having "substantial experience in the area of water resource management" (HRS 174C-7(b)). Beyond that, it is essential for the Senate to know that nominees understand why the CWRM has so often been overturned by the courts.

Kamana Beamer, one of the two nominees to CWRM before you today, clearly meets these two tests, and he exceeds nearly every other Commissioner I have seen in his understanding of the Code and its implementation. I would strongly encourage you to ask all of your nominees to CWRM detailed guestions about how the Code operates and the duties of a Commissioner. This will help you establish for yourself how very qualified Dr. Beamer is to continue to serve in this role.
