The Administration of the Office of Hawaiian Affairs (OHA) will recommend that the Board of Trustees <u>SUPPORT</u> GM821, which would confirm Lori Buchanan to a first term on the Game Management Advisory Commission (GMAC).

Native Hawaiian subsistence practitioners i ka wā ma mua (of the time long before), developed their skills and customs in synthesis with the natural world around them. For them, the concepts of subsistence and survival, carefully attuned to Hawai'i's unique environment and ecology, was dependent upon the precise management of these islands' natural resources. The legacy of this art-form of subsistence and sustainability, passed down through generations, has evolved into what are now recognized as Native Hawaiian traditional and customary practices, which today include practices reliant upon the availability of both native and human-introduced flora and fauna.

Game hunting remains an important cultural and subsistence activity for many Native Hawaiians, particularly in rural regions, and in many cases may be considered a constitutionallyprotected Native Hawaiian traditional and customary practice. For example, a report issued by the Governor's Moloka'i Subsistence Task Force found that Hawaiian families on Moloka'i continued to rely heavily upon subsistence to supplement their meager incomes, deriving 38% of their food from these activities. This report revealed that subsistence activities, including hunting, were also critical to the persistence of Native Hawaiian culture and values. Updated data from 2014 found that Native Hawaiians on Moloka'i continue to state that subsistence is "very important" for their family's livelihood.

Accordingly, OHA appreciates the requirement that at least one GMAC member possess knowledge, experience, and expertise in the area of Native Hawaiian cultural practices, and supports nominees with a demonstrated and culturally-grounded respect for the need to manage, protect, and promote both natural resource conservation and public hunting in the state, consistent with traditional understandings and values. **As a subsistence hunter and cultural practitioner, Mrs. Lori Buchanan clearly possesses a deep and culturallygrounded understanding of the need to accommodate and appropriately balance Native Hawaiians' subsistence hunting needs with the protection of our natural and cultural resources; OHA believes that her appointment would be invaluable to the GMAC's efforts to ensure that hunting in Hawai'i can be appropriately maintained and managed for present and future generations.** Mrs. Buchanan is a Native Hawaiian from the island of Moloka'i, where subsistence hunting is a large part of many resident families' lifestyles. She has an extensive record of service on various advisory councils and commissions, concerning diverse subjects that include natural resource management, land use and planning, and invasive species control. Mrs. Buchanan currently serves as Po'o (head) of the Moku (district) of Pālā'au, Moloka'i, as part of the Moloka'i 'Aha Kiole, where she provides expertise on ahupua'a (watershed) resource management as a hunter-practitioner. Mrs. Buchanan is also an accomplished hunterpractitioner with a substantial amount of relevant certifications that serve as a testament to her expertise, leadership, and experience in the management, protection, and promotion of public hunting in Hawai'i. Mrs. Buchanan's interests are therefore demonstrably rooted in protecting Hawai'i's natural resources and perpetuating the traditional and customary practices of Native Hawaiians, including subsistence hunting.

Accordingly, OHA urges the Committee to **PASS** GM821. Mahalo for the opportunity to comment on this measure.
