Aloha Senator Gabbard,

Please see responses to questions posed by your committee regarding my interest in serving on the Advisory Committee for Pesticides.

- 1. Why do you wish to be a member of the Advisory Committee on Pesticides? I am interested in serving on the Advisory Committee on Pesticides as this is a critical component of the future of agriculture in our State and also could have a significant impact on the health of our environment in our State.
- 2. How do you perceive the roles and responsibilities of a member of the Advisory Committee on Pesticides? The role of a member of this committee is to help determine whether certain pesticides have a place in the State Agriculture Industry and also to make sure that there are little to no impacts to our greater environment within the State. This includes: which chemicals are allowed in the State, review of their impacts as studied by various sources (industry, governmental, etc.), how the pesticides are used, and the health of our workers utilizing the pesticides, etc.
- 3. Given your understanding of the role and responsibilities of a member of the Advisory Committee on Pesticides, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Advisory Committee on Pesticides. I am an engineer by training and thus have been schooled in analyzing situations and determining a balanced, best course of action to address that situation. In addition, I have previously served on this same committee during an intensive time of re-writing of the rules and had to learn of the various aspects of consideration regarding pesticides approval and usage. Finally, I currently sit on the EPA's National Environmental Justice Advisory Council (under the Federal Advisory Commission Act - FACA). Exposure on this Council has given me insight into: farm worker protection standards, farm worker health issues, etc., and access to various aspects of the EPA for further information/education on various environmental issues.
- 4. What do you hope to accomplish during your term of service? To provide the oversight and guidance required for the program to make sure that the State of Hawai`i not only provides the best tools for our agriculture community/industry and also make sure that appropriate protections are in place for the health and well-being our of residents and the environment.
- 5. Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Advisory Committee on Pesticides? I do my research, am persistent and will work an issue to completion. In all situations calling for an opinion or guidance, I make sure that I learn and investigate the situation to the best of my ability. I do not like to make judgments with no basis. I will continue to ask questions until satisfied and understand the problem or issue. Lastly, I tend not to "quit" on an issue but will follow-through with completion. I believe all of these qualities will benefit the committee and all of these add to the betterment of the guidance provided by the Dept. of Agriculture on any Pesticide issue.
- 6. Name one previous experience that would make you stand out. How would this benefit the

Advisory Committee on Pesticides? I have previously served on this same committee and bring with me the knowledge gained during those two terms served, including being a participant on the last major rule re-write of the Pesticides Rules.

7. Can you foresee any possible conflicts of interests that could arise during your service on the Advisory Committee on Pesticides? How would you overcome any possible conflicts of interest? I do not see any specific potential of a conflict of interest arising by sitting on this committee. I do have many contacts and connections with both the agricultural industry, farmers, and environmentalists though. If there would be as conflict of interest, I would see if there might be a compromise with these constituents and if not then recuse myself from any decision-making on that specific issue/topic.

I hope these responses provide you a better insight into my commitment and abilities to be able to serve on the Advisory Committee on Pesticides and win your favorable consideration.
