# TESTIMONY OF SCOTT E. ENRIGHT CHAIRPERSON, BOARD OF AGRICULTURE

BEFORE THE HOUSE COMMITTEE ON AGRICULTURE

HOUSE BILL NO. 1007 RELATING TO AGRICULTURE

Chairperson Creagan and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 107 that establishes within the Department of Agriculture a Korean natural farming pilot project that will promote the use of Korean natural farming (KNF) techniques to combat various agricultural pests in Hawaii. Funding for the pilot project's coordinator position is to come from the Agricultural Development and Food Security Special Fund. The "barrel tax" amount to food security, currently set at 15 cents of the tax on each barrel, is blanked out. The amendment to direct barrel tax funding establish the Pilot Program in Section 141-10(c) (page 3, lines 10-12), and the amendment to blank out the amount of tax on each barrel deposited into the Agricultural Development and Food Security Special Fund in Section 243-3.5(a)(4) (page 4, line 16) are both to be reenacted in their original form upon the repeal of this Act. The Department of Agriculture supports the intent of this measure provided it does not impact the Department's priorities submitted in the Executive Budget and offers comments.

The Department of Agriculture is uncertain how the promotion of KNF via a KNF coordinator within the Department of Agriculture will result in the collection of data and information leading to findings, recommendations, and proposed legislation on pest and

disease control. This is not work that the Department has historically done; HDOA advocates for all of Hawaii's agricultural sectors. Additionally, the Department has undertaken projects with the University of Hawaii CTAHR – Extension Service to start the process of demonstrating the science to support the viability of Korean farming methods.

We are also concerned about the proposed amendment to Section 243-3.5 (Bill, page 4, lines 13 to 19) to "blank out" the existing 15-cent portion of the "barrel tax" going to the Agricultural Development and Food Security Special Fund and to utilize this fund for a program position with an uncertain pilot program timeframe.

Should the Committee decide to pass this measure, we ask that sections 2 and 3 be deleted and that the KNF position be allotted general funding.

Thank you for the opportunity to submit our testimony.
