In consideration of HB1039 RELATING TO FUNDING FOR CREATIVE MEDIA AND FILM DEVELOPMENT

Chair Nakashima, Vice Chair Keohokalole, and Members of the House Committee on Economic Development & Business.

The Department of Business, Economic Development and Tourism (DBEDT) **strongly supports** HB1039, which would amend and redefine the existing special fund (HRS §201-113) to establish the Creative Media and Film Infrastructure Special Fund, provides a mechanism to capture rental fees from the current Hawaii film studio, along with film permit and tax credit application fees, and expend these funds to support the infrastructure repair and maintenance of current and future studio facilities.

Film production activity has maintained a steady \$200M to \$250M per year in production expenditures and is on course to increase in 2017. The Hawaii Film Office currently has \$105,000 in general funds and \$30,000 in HTA special funds for repair and maintenance of the facility. Currently, ongoing repair and maintenance costs average approximately \$150,000 per year. The 16,500 square foot sound stage which was purpose built in 1994, is now over 20 years old. There are portions of the facility which have not undergone major renovations and these areas require more repair and maintenance.

By providing the ability to deposit and expend film studio rent payments and fees as noted, the program can allocate special fund revenues to the R&M of the existing 7-acre facility and future new infrastructure development. The Hawaii Film Office will also be able to 1) increase the level of marketing for the

We support HB 1039, which provides for the expansion of funding sources to support creative industries development with the following comments and suggestions.
