#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 396-11.5, Hawaii Revised Statutes, is

#### JUSTIFICATION SHEET

Labor and Industrial Relations

DEPARTMENT:

TITLE: A BILL FOR AN ACT RELATING TO THE HAWAII LABOR RELATIONS BOARD. PURPOSE: To provide for electronic notification of hearings. To require the party seeking review of a decision and order of the Hawaii Labor Relations Board (HLRB) to pay the costs of a transcript, except as provided by law, in which case HLRB is required to pay the cost. Amend sections 396-11.5(a) and 396-12, MEANS: Hawaii Revised Statutes (HRS). JUSTIFICATION: Section 396-11.5(a), HRS, currently provides for written notice of hearing by first class mail. The proposed revision allows HLRB to notice parties to hearings electronically. This revision, if enacted, will save HLRB the cost of postage and paper, provide a guicker delivery method, and accommodate parties who are not located on Oahu and who may be disadvantaged by having documents mailed. The proposed amendment to section 396-12, HRS, would require the party appealing HLRB's decision and order to bear the transcript costs, except as provided by law, in which case HLRB will bear the costs. This will save HLRB from bearing the costs of transcripts for every appeal and share the costs with parties that are not statutorily exempt. Impact on the public: The electronic service of hearing notices is a faster and less expensive way to provide notices to parties. The flexibility of being able to serve and be served with hearing notices through electronic means also accommodates parties who are not located on Oahu.

	Impact on the department and other agencies: Authorizing the use of electronic service as another means of delivering a written notice of hearing will save the department postage costs and staff time.
