The Office of Hawaiian Affairs (OHA) Beneficiary Advocacy and Empowerment Committee will recommend that the OHA Board of Trustees <u>COMMENT</u> on HB118 HD1, which would prohibit candidates for the OHA Board of Trustees from being registered as a lobbyist within one year of filing their nomination papers.

As the constitutionally-established body responsible for protecting and promoting the rights of Native Hawaiians,¹ OHA has substantive obligations to protect the interests of the agency's beneficiaries.² OHA is required to serve as the principal public agency in the State of Hawai'i responsible for the performance, development, and coordination of programs and activities relating to Native Hawaiians; assess the policies and practices of other agencies impacting Native Hawaiians; and conduct advocacy efforts for Native Hawaiians.³ OHA is further responsible for managing and administering the funds, real property, and other assets it holds in trust for the benefit of Native Hawaiians.⁴

OHA appreciates the intent behind HB118 HD1, to better ensure that OHA Trustees uphold the agency's obligations, and act in the best interests of OHA's Native Hawaiian beneficiaries. OHA notes that state officials, state employees, and elected officials, including OHA Trustees, are generally not required to register as lobbyists to advocate in their official capacities.⁵ They would, however, have to register as a lobbyist if advocating outside of their official kuleana (responsibilities). OHA understands that their unique and specific responsibilities to OHA's beneficiaries may distinguish OHA Trustees from other elected officials, in their non-official lobbying activities.

At the most recent meeting of the Beneficiary Advocacy and Empowerment Committee, which is a committee of the whole, OHA Trustees expressed a variety of views about HB118 HD1. Some Trustees believed that HB118 HD1 would clarify that a Trustee should not represent interests outside of and in potential conflict with their official responsibilities, while before the legislature or other government body; some Trustees also believed that this measure would reduce confusion as to what "hat" a Trustee may be wearing, in his or her advocacy efforts. However, at least one Trustee also raised concerns about the measure, as a possible encroachment on OHA's autonomy, among other reasons. OHA looks forward to continuing discussion on HB118 HD1, as it moves through the legislative process.

Mahalo nui loa for the opportunity to testify on this measure.

TESTIMONY IN OPPOSITION

I'll begin my testimony to a committee on Hawaiian affairs with a sentence in Hawaiian language.

Hupo loa ke kanaka po'o o keia komike, i ho'okomo i keia pila HB 118 HD1.

Although this hearing is set for Valentines Day, I have no love for this bill nor for its sponsor.

Who is to blame for this bad bill?

The chairman of this committee is, shall we say, badly misguided for introducing this bill, whose contents display an astounding level of ignorance about the history of litigation regarding candidacy for OHA trustees.

One of the major provisions in this bill is flat-out unconstitutional -- a fact litigated and ruled by two federal courts. The other major provision might also be unconstitutional, although it has not yet been litigated; but it is certainly immoral if not illegal.

The following members of this committee also deserve blame for rubber-stamping this bill when they voted on February 3 and February 7 to pass this bill as amended: Ing, Gates, Creagan, DeCoite, LoPresti, Takayama, Thielen; no Noes and no reservations. You committee members really must exercise greater vigilance in monitoring the work of your very youthful and reckless chairman. He might be excused because the massively publicized litigation on this issue happened when he was a mere prepubescent boy; but if he's going to be a committee chairman then he should compensate by having a knowledgeable advisor. Most committee members have no such excuse -- if you're older than 40 and have lived in Hawaii for at least 18 years then you will surely remember the tumultuous events of year 2000.

What's one major bad thing about this bill?

Lines 3,4,5 on page 1 say "No person shall be eligible for election or appointment to the board unless the person is Hawaiian and ..."

That racial restriction on candidacy has been ruled unconstitutional by the U.S. District Court in Honolulu and by the 9th Circuit Court of Appeals.

Of course this committee could rescue that provision by redefining the word "Hawaiian" to mean "citizen of Hawaii" rather than the racially exclusionary meaning requiring at least one drop of Hawaiian native blood.

I would welcome such a redefinition. Please do it! But of course you won't; so let me continue.

Here's the story.

In year 2000 the U.S. Supreme Court by vote of 7-2 ruled in Rice v. Cayetano that there can be no racial restriction on who can vote in the election for OHA trustees.

Later in year 2000 the U.S. District Court in Honolulu, Judge Helen Gillmor presiding, ruled that there can be no racial restriction on who can run as a candidate for OHA trustee. The case was CV 00-00514 HG-BMK Arakaki et. al. vs. State of Hawaii et. al, and OHA as intervenor. I was honored to be among the multiracial group of 13 plaintiffs including 3 Native Hawaiians. We won.

Governor Cayetano ousted all nine OHA trustees on grounds they had been illegally elected.

In the election of November 2000 I ran as a candidate for OHA trustee, along with 95 other candidates for the 9 seats. There were at least a dozen so-called "non-Hawaiians" [Hawaii citizens with no native blood] among the 96 candidates; and one of them, Charles Ota, won the Maui seat. Judge Gillmor's civil rights racial desegregation decision was appealed to the 9th Circuit Court of Appeals, and was upheld by the three-judge panel, with the final judgment filed on July 1, 2003 by Honolulu clerk Walter Chinn.

The judgment concludes: "... The State is ordered to permit otherwise qualified non-Hawaiians to run for office and to serve, if elected, as trustees of the Office of Hawaiian Affairs. Section 5 of Article XII of the State Constitution and HRS § 13D-2 violate the Fifteenth Amendment and the Voting Rights Act, to the extent that they require persons running for OHA trustee positions and serving, if elected, to be Hawaiian."

What's the other thing wrong with this bill?

The other major new provision of this bill might very well also be unconstitutional. It says "No person shall be eligible for election or appointment to the [OHA] board unless the person is ... Not registered as a lobbyist within one year of filing nomination papers."

To the best of my knowledge there is only one person serving as an OHA trustee or who was recently a candidate for OHA trustee who would be no longer eligible to be OHA trustee under provisions of this bill. I guess your committee chairman has a vendetta against him, and is (ab)using his power as a committee chairman to pursue that vendetta.

Article I, Section 9, Clause 3 of the U.S. Constitution says "No Bill of Attainder or ex post facto Law shall be passed."

The Heritage Foundation's Guide to the Constitution says "The Constitution prohibits both the federal government (in this clause) and the states (in Article I, Section 10, Clause 1) from passing either bills of attainder or ex post facto laws. The Framers considered freedom from bills of attainder and ex post facto laws so important that these are the only two individual liberties that the original Constitution protects from both federal and state intrusion. As James Madison said in The Federalist No. 44, "Bills of attainder, ex post facto laws, and laws impairing the obligation of contracts, are contrary to the first principles of the social compact, and to every principle of sound legislation."

So even if this bill might somehow escape being ruled unconstitutional as a bill of attainder, it would clearly not be able to oust the victim of your chairman's vendetta from his OHA trustee position where he will serve for nearly four more years; because passing this bill after the victim has already been elected and is serving would be an "ex-postfacto" law.

My dear committee members: Does this testimony seem disrespectful? Then consider where the disrespect originated. Introducing this clearly unconstitutional bill is disrespectful to the judiciary. Advancing this bill is disrespectful to the oath all legislators take to support and defend the Constitution of the United States. Using the power of a legislature's committee chairman or member to press a vendetta attempting to oust an elected official without impeachment and trial on charges of misbehavior is disrespectful to the will of the public who elected him and disrespectful to the whole concept of democracy and due process.

Trash this bill. It has already tarnished your reputations, but you can mitigate the damage.

Aloha State House of Representatives and the OHA Board of Trustees,

Thank you very much for this opportunity to submit testimony. This submission is to express our very strong SUPPORT for House Bill 118 ("HB 118"). *(see bill below)*. Mahalo to Maui House Representative Kaniela Ing for helping to bring pono leadership to the Office of Hawaii Affairs at a time when this agency has been at the center of so many controversies. We are grateful he has taken the lead on this very important issue! This petition is by the members of the Pono Leadership Group, a grassroots initiative, which was formed in 2017 after concerns emerged in the community regarding OHA's board leadership. Ninety percent (90%) of our members are Native Hawaiian beneficiaries.

As a group, we advocated for the OHA board to be reorganized in February 2017 and prevailed at a time when our community so desperately needed it. Together, we are committed to stronger, more transparent and values based leadership for agencies that manage Native Hawaiian resources such as OHA. Our primary objective is to make agencies such as OHA stronger not only for this generation but for generations to come. We appreciate the legislature assisting in any way it can so we can address issues collectively as partners for a better Hawai'i for our keiki.

We support HB 118 because this bill will prevent registered lobbyists from serving or being elected to the OHA Board of Trustees. HB 118 is important because it will increase board transparency and prevent outside sources from influencing the board's decisions or operations. HB 118 will also protect against fraud or misuse of confidential information related to the agency itself by any registered lobbyist who may serve in a dual capacity. Currently, no State Senator or House Representative are paid lobbyists who are able to lobby the legislature. We would like and STRONGLY SUPPORT a rule such as this to apply to OHA Trustees as a critical step to protect the integrity of the board.

As beneficiaries and citizens of Hawai'i, we write to you with great concern regarding Keli'i Akina who is a registered lobbyist *(see Akina's lobbyist registration below)* of the Grassroots Institute of Hawai'i ("Grassroots") and an elected Trustee. Grassroots has historically been committed to eliminating Native Hawaiian programming.

We do not support any Trustee who has a dual role such as this. As a paid lobbyist of Grassroots, Akina must carry its mission forward which, in the past, has been to target Native Hawaiian programming. On the other hand, Trustee Akina has a fiduciary duty to protect OHA's programming for Native Hawaiian beneficiaries. We reject dual representation such as this and would like to build in protections not only to address the current circumstance but also to protect the future. We are humbly calling upon Trustee Akina to choose one role, either serve as Trustee OR Executive Director of Grassroots, not both.

To be very clear, HB 118 is a separate issue from the audit. We believe both efforts can be pursued together to increase transparency of the agency as a whole. While our group has not taken an official stance on the audit, we encourage the OHA board to engage in discussions with beneficiaries who have called for it.

HB 118 is NOT SPECIAL LEGISLATION because it protects the board and can be applied to any candidate or Trustee.

We are asking for your support to address our current concern but also to protect the future of our precious beneficiaries by strengthening and preserving the transparency of the board.

In the end, HB 118 will serve the best interests of beneficiaries and Hawai'i as a whole in the years to come.

Aloha, the Association of Hawaiian Civic Clubs (AHCC) is comprised of sixty-four component member clubs in Hawaii and fourteen states on the continent. The first civic club was organized in 1918 by Prince Kuhio and a group of prominent Hawaiian men when Kuhio was a Delegate to the US Congress. Kuhio recognized the need for Native Hawaiians to become more involved in the passage of the Hawaiian Homes Act then before the Congress, and to further become engaged in the intricacies of federal and local government. Beginning with the Hawaiian Civic Club of Honolulu, one hundred years ago, the movement expanded and never deviated from its course to be involved in those issues of importance to Native Hawaiians. Each year there is a convention that brings delegates together to discuss and consider issues that have been submitted by clubs via written resolutions. If adopted by the body, AHCC resolutions that require follow up are subsequently acted upon.

On November 13th to November 20, 2016 the members of the Hawaiian Civic Clubs met in Convention at their 57th Annual Convention in Las Vegas, Nevada. As part of the work of convention, the delegates met in various committees to discuss resolutions authored by the clubs and took action on these resolutions. These resolutions were then discussed in Plenary session and adopted by the majority of delegates. One resolution: Resolution 16-44 Expressing Concern over Office of Hawaiian Affairs Trustee-Elect Dr. Keli'i Akina's Conflict of Interest Given His Position As the President/CEO of the Grassroots Institute of Hawai'i we bring to your direct attention today because of the action pending before this House Committee.

This resolution was mailed to Trustee Akina as well as the Chairperson of the Board on Friday, November 25th, 2016. I received an email from Trustee Akina's aide on December 9th, 2016 with a five page attachment, which I am giving to the Chairman of this committee. The attachment had a one page letter from Trustee Akina and two enclosures, one, an undated "Position Statement on Native Hawaiian Issues" by Keli'i Akina and the other a letter from Michael A. Lilly, Attorney at Law, addressed "to whom it may concern" dated December 7, 2016 stating in part"....OHA is an agency <u>of and by all the people of</u> <u>Hawai'i</u>"....and further..."Importantly, the U.S. Supreme Court's decision in Rice v. Cayetano established that the Constitution required that OHA voters and trustees be open to all citizens and not just Native Hawaiians. Thus, the Association of Hawaiian Civic Club's resolution's premise runs counter to the Rice holding." It is the continued and intentional misinterpretation of the responsibility of the Office of Hawaiian Affairs Trustees by Dr. Akina and his representatives of the Grassroots Institute that brings us before you today and causes us to support HB 118 HD1.

Rice v. Cayetano was an issue of voting, with consideration of the voting rights as defined in the Federal Voting Rights Act which disallows racial preferences. The United States Supreme Court's ruling related only to voting rights, the Supreme Court took no position, nor made any statement about the Office of Hawaiian Affairs and its responsibilities in the public land trust to Native Hawaiians, nor to the responsibilities or duties of the Trustees.

The "Purpose of the Office of Hawaiian Affairs and the responsibilities of the Trustees" are defined in the Hawaii State Constitution and in Chapter 10 of the Hawaii Revised Statutes, specifically 10-3, which states, in part: "The purposes of the office of Hawaiian affairs include: (1) The betterment of conditions of native Hawaiians. A pro rata portion of all funds derived from the public land trust shall be funded in an amount to be determined by the legislature for this purpose...." (2) the betterment of conditions of Hawaiians; (3) serving as the principal public agency in this State responsible for the performance, development, and coordination of programs and activities relating to native Hawaiians and Hawaiians(4) assessing policies and practices of other agencies impacting on native Hawaiians and Hawaiians and Hawaiians and conducting advocacy efforts for native Hawaiians and Hawaiians. (5) applying for, receiving, and disbursing, grants, and donations from all sources for native Hawaiian and Hawaiian programs and services; and (6) serving as a receptacle for reparations..." Please note, there is nothing here about "all the people of Hawaii".

The Hawaii Revised Statutes are very clear on the powers and duties of the Board of Trustees, see 10-5 in which all powers and duties related to the pro rata share of the public land trust for the benefit of native Hawaiians and Hawaiians. From subsection 1 to 9 or 10-5 the references of the powers and duties for the trustees is on to native Hawaiians and Hawaiians and clearly states in (4) "....policy relating to the affairs of native Hawaiians and Hawaiians...shall not diminish or limit the benefits of native Hawaiians under article XII, section 4, of the Hawaii State Constitution...."

Dr. Akina, when he was campaigning for Trustee of OHA stated: "A second reason I'm running is because this agency called the Office of Hawaiian affairs needs to be held accountable to fulfill its mission of serving Hawaiians and <u>all the people of Hawaii."</u>

Dr. Akina went on to say " by meeting the needs of everyone, we can meet the need of Hawaiians." Further he said " I praise the work of OHA and other organizations for the safety net they've provided to Hawaiians and I want that safety net extended to EVERYONE in need". He says, "OHA belongs to and must serve everyone in Hawaii, Hawaiians by blood and Hawaiians at heart."

Dr. Akina is a graduate of Kamehameha Schools, his children attended Kamehameha Schools, however, in the Grassroots Institute's Amicus brief on OHA v State of Hawaii it states: "Over one million American citizens in Hawaii are under siege by what can fairly be called an evil empire dedicated to Native Hawaiian Supremacy. That empire is dominated by KSBE, the nation's largest charitable trust, which has already conquered Hawaii's government and much of its business establishment. Even the United States supports this invidious discrimination by annually funding multiple Hawaiian entitlements; and by failing to disavow the Hawaiian homelands compact in the Admissions Act which mandates that the State of Hawaii keep on discriminating on the basis of race."

As previously noted, the Trustees of OHA have a responsibility to advocate for Native Hawaiians, and OHA has acted in this role honorably, however, Dr. Akina characterized many positions OHA has taken on Native Hawaiian traditional and customary rights, rights of shoreline access, the water code's recognition of kalo cultivation as a public trust purpose, and the legal protection of iwi kupuna as "racial entitlements that strip landowners of rights they would expect in other states"... this is hardly a voice of advocacy of Native Hawaiian rights.

Trustee is the most sacred of legal relationships in law. Trustee is tightly regulated and monitored by law. The Trustees of the Office of Hawaiian Affairs protect, grow, and administer 20% of the pro rata share of the public land trust for the benefit of native Hawaiians and Hawaiians.

Dr. Akina has been elected to be Trustee of the beneficiary class of native Hawaiians and Hawaiians only....we agree with the additional language amending Chapt 13-D-2 (3) relating to the qualifications of board members, specifically "...no person shall be eligible for election or appointment to the board unless the person is Hawaiian and is:...(3) Not registered as a lobbyist within one year of filing nomination papers. "

The Trustees of OHA recommend policies for the management of the agency's investment portfolio and other fiscal and budgetary matters. They also develop policies and guidelines for OHA's land acquisitions, dispositions, development and management. Our Trustees must remain focused on the management of the 20% pro rata share of the public land trust to the benefit of the Native and native Hawaiian community. The fidelity of our Trustees must be singular. They cannot serve two masters....Dr. Akina cannot lobby for OHA and lobby for the Grassroots Institute.

As President of the Association of Hawaiian Civic Clubs, I stand by the concerns raised in our Resolution 16-44 "expressing concern over OHA Trustee-elect Dr. Keli'i Akina's conflict of interest given his position as the President/CEO of the Grassroot Institute of Hawaii" and as a registered lobbyist of the Grassroots Institute. Mahalo for allowing me to testify today.
