In consideration of **HOUSE BILL 785 RELATING TO** THE HAWAII ASSOCIATION OF CONSERVATION DISTRICTS

House Bill 785 proposes to appropriate \$450,000 of general revenues in Fiscal Year 2017-2018 and Fiscal Year 2018-2019 for operating expenses and staffing costs of the Hawaii Association of Conservation Districts (HACD). The Department of Land and Natural Resources (Department) supports this bill provided that its passage does not replace or adversely impact priorities indicated in our Executive Budget request.

The purpose of the Soil and Water Conservation District (SWCD) Program is to educate, construct, maintain, and assist in the development of conservation plans to protect soil and water resources. Each SWCD is operated by a five-member volunteer board. HACD is an umbrella organization formed by the 16 SWCDs under Chapters 180 and 180C, Hawaii Revised Statutes, and administratively attached to the Department. In each of fiscal years 2015-2016 and 2016-2017, HACD and the SWCDs received \$322,500 in general funds, appropriated by Act 84, Session Laws of Hawaii 2015. The Department notes that the SWCD Program does not have a base budget appropriation and funding would be required for the continuance of their activities.

Comments: The Puna population has been growing incredibly fast - more than 24% between the 2000 and 2010 Census, and more than 2% annually since then. Yet many of the beach areas have been covered by lava, and the flows have not stopped. This leaves the Puna residents with very little in the way of safe swimming spots. Places like Pohoiki, with a mixed use of fishing boat launching and keiki swimming are not an example of safe compatible uses. Yet there is another area nearby that could provide safe swimming if some minor renovations are made. A feasibility study would give DLNR the information necessary to take this to the next stage and help bring the level of service up to an acceptable level. Please support this bill. mahalo.

Comments: The Hawai'i island population has grown by over 25% in the past decade, with the bulk of the growth in the Puna district. The Pohoiki Boat Ramp is the only safe ocean access in all of Puna, approximately 60 miles of coastline. Puna contains over 20 subdivisions, with 45% of Hawai'i island's total subdivided lots (totaling over 50,000 lots). Since the 1991 inundation of Kalapana by lava, public use at Pohoiki has multiplied significantly. Phase I of the new County Isaac Hale Park was completed after 17 years (in 2008). Currently, the public swims at the boat ramp, even though signs are posted, "No Swimming." There simply are no other options! Boats go in and out at the ramp continuously every day; during peak times there are over 100 people in the water and at the boat ramp area. This is an urgent safety issue, especially when boat traffic increases. The public needs safe swimming away from the ramp. There is a lagoon area away from the ramp on the other side of (unfinished) Phase II of Isaac Hale Park. The current situation is an accident waiting to happen! Therefore, we strongly support a feasibility study and whatever it takes to provide a safe swimming area at Isaac Hale Park in Pohoiki. Your attention to this growing safety issue is urgently needed! Mahalo for this effort to serve the people of Puna Makai. Aunty Luana
