<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) appreciates the intent of this bill as teachers and students need to know and recognize child abuse and neglect in order to protect children or children to protect themselves, and obtain the help they need. The DHS offers the following comments: it is not necessary to legislate the DHS to develop signage publicizing the Child Welfare Services hotline number, as the current collaboration between the DHS and the Department of Education (DOE), along with access to the internet provide adequate access for DOE staff and students to report suspected child abuse and neglect.

<u>PURPOSE</u>: The purpose of the bill is to increase access and visibility of the Child Welfare Services (CWS) hotline number within the DOE schools and charter schools, and to enable students and victims to better self-report.

DHS works closely with the DOE to provide in-service training to its staff regarding the Child Protective Act and the mandated reporter responsibilities. We will continue to work with the DOE to ensure that the CWS hotline number is visible and accessible in the DOE and charter schools.

Regarding a campaign directed at school children so they are able to self-report, as part of its work with the Safe and Nurturing Families Team (Team #2) of the Action Strategy public-

private partnership addressing Hawaii's early childhood system, Team #2 has been working on a broader child abuse & neglect prevention outreach campaign.

DHS informs the committee that any outreach to school aged-children should be developmentally appropriate and cannot simply be a posted sign. Using public campaign materials developed by University of Manoa, Fine Art students in conjunction with Team #2, the materials were presented to early childhood providers, both public and private, and the group was surveyed. Survey results are still being compiled, though a number of conclusions can be drawn from the preliminary survey responses:

- Images and messaging need to be clear and easy to comprehend; many suggested that images and messaging be positive and encouraging to reach out, as opposed to being ominous or contain strong visuals with mixed messages;
- 2. Images and messaging need to be developmentally appropriate, and outreach efforts will differ depending on age requiring different strategies for elementary, middle and high schools are required;
- 3. Materials for parents should accompany any outreach campaign made directly to children;
- 4. Materials and training for DOE staff should accompany the outreach materials; and
- 5. Testing of the materials and feedback from focus groups should be done and obtained prior to any roll out.

Other comments of note were:

- materials should not be provided to parents as parents may discourage their children from calling the hotline and it could potentially lead to threats to children or more abuse;
- poster campaigns are not effective; what is needed is training to raise awareness
 of teachers, counselors and staff;
- DOE staff may require more training as to what to do and how to support a child who reports something;
- A curriculum should be developed with messaging that informs kids where they
 can turn to if they are abused in any way;
- A school's over all message should be that it is a safe place; and

• Provide training on trauma, how to accept/support children who we know are experiencing trauma.

Consequently, while work has been on-going to design an outreach campaign, more work is required. Collaboratively, through Action Strategy, DHS, DOE and the Department of Health are working together to develop an appropriate outreach campaign; consequently, a statutory mandate is not required.

Comments: I have worked in the early education field since 2006 (about 9 of those years as a preschool teacher) and have seen the major progress a child makes from birth through five. I have seen the gains that children make who start their path to learning early and I have seen the struggles that children who start later run into compared to their peers who had an earlier start. When I hear the statistic that 90% of brain growth is done before age 5 it seems almost common sense to me. But I had been a preschool teacher for nearly 9 years and have first hand knowledge of this. According to Hawaii Children's Action Network, children who don't receive quality early education are: 25% more likely to drop out of school 40% more likely to become a teen parent 50% more likely to be placed in special education 60% more likely to never attend college 70% more likely to be arrested for a violent crime I support HB 578 because it extends access to education for children who are in our most vulnerable communities. We owe it to them to give them a fighting chance so they can crawl out of poverty. If we do not give our keiki the tools to succeed then we cannot be surprised when they don't. I urge you to pass this measure.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports the intent of these measures provided that passage of either does not replace or adversely impact priorities in the Executive Budget and existing operations. The DHS offers comments, in particular, if the Legislature expands the eligible population to the Preschool Open Doors Program (POD), DHS will need adequate administrative resources to implement the program changes, and sufficient time to amend relevant rules, re-procure for services, and address operational needs such as modifications to the IT system.

<u>PURPOSE</u>: The purpose of HB 388 is to reestablish eligibility for the preschool open doors program to 3- and 4- year old children prior to entering kindergarten.

The purpose of HB 578 is to expand the qualifying age for the preschool open doors program to children four years old and younger.

The POD program assists low and moderate income families who are least able to afford preschool and provide their children with the opportunity to be ready for kindergarten by providing child care subsidies for preschool costs. Act 169, Session Laws of Hawaii (SLH) 2013, established the POD program as the statewide school readiness

program and appropriated \$6 million in general funds for state fiscal year (FY) 2015 for program and administrative costs, including 3 temporary positions. Act 191, SLH 2015, appropriated \$6 million in general funds for FY 2016, however the legislature did not provide administrative funding or temporary positions. Act 124, SLH 2016, allocated an additional \$10 million to DHS base budget for a total of \$11.6 million for FY 2017 for POD subsidies. Act 124, SLH 2016, also provided allocations for administrative costs, including 1 permanent position.

DHS provides the following comments:

1. Provision of necessary administrative resources for DHS – staffing, Executive Budget request.

To continue the current POD program, the Governor's current budget request for POD includes a full year of funding for FYs 2018 and 2019 for the 1 permanent position established through Act 124, SLH 2016. DHS requires the full time position and administrative funds to effectively monitor and implement POD at FY 17 levels, and to provide on-going review of contract deliverables and performance measures.

Without the appropriate level of administrative resources, it will be difficult to implement the program as the legislature intends; expanding the program population without addressing administrative resources will be problematic.

HB 388 as drafted would expand the POD program to serve 3 year old children, as well as 4 year old children. HB 388 also would provide an additional \$12 million in POD subsidies to families for FYs 2018 and 2019. However, no appropriation for administrative costs is currently included in HB 388.

HB 578 as drafted would expand the POD program to serve children younger than 4 year old children, as well as 4 year old children. However, there is no additional appropriation to fund the program which may result in a waiting list.

2. Unintended consequence: decreasing services to 4 year olds.

DHS is concerned that allowing families with younger children to participate in the POD program may have unintended consequences of decreasing services to the 4 year old

population. Recall, that with the change of entry age to kindergarten,¹ to ensure learning opportunity and improve kindergarten readiness, the Legislature identified the 4 year old population as the priority of Act 169, SLH 2013.

Currently, there are 1,751 4 year old children participating in the POD program. Kindergarten enrollment is approximately 16,000 children each year. POD serves about 10% of the population of children who are eligible for kindergarten in the following year.

For HB 388 and HB 578 as drafted, if a child younger than 4 years old is underserved or at-risk, the younger child will have priority for POD services over a 4 year old child who is not underserved or at-risk, which runs the risk that the 4 year old does not have the learning opportunity as set forth in Act 169, SLH 2013.

HB 578 does not provide an increased appropriation for POD subsidies, yet the number of eligible children may increase by an estimated 400%, assuming a steady birth rate each year for children birth through 3 years of age. To be viable and avoid large waiting lists, funding for POD subsidies would need to increase.

3. Technical concern regarding ages of children that can be served by a preschool.

Over time, different child care and preschool programs were created to serve specific needs or populations. The enabling statutes created specific mandates, administrative rules and licensing provisions were created to implement and administer the multiple changes.

DHS needs clarification whether POD services can be provided to children less than 2 years of age, as there are separate licensing requirements between group child care centers and group child care homes (i.e. preschools) versus the licensing requirements for infant and toddler child care centers which serve children ages 6 weeks to 36 months in age.

The current POD program only allows POD services at group child care centers and group child care home.

¹ Act 178, SLH 2012, repealed junior kindergarten programs at the end of the 2013-2014 school year, and beginning with the 2014-2015 school year, required students to be at least five years of age on July 31 of the school year in order to attend kindergarten.

4. Provision of necessary administrative resources for DHS – funding.

Regarding HB 388, DHS estimates that the additional \$12 million in subsidies could serve another 1,855 children, for a total of 3,655 children with \$23.6 million in POD subsidies.

DHS respectfully notes that doubling the amount of POD subsidies to be awarded by DHS will increase the administrative oversight needed for the program. DHS estimates that \$411,500 each for FYs 2018 and 2019 to implement the program at the level of additional funding and to expend the full amount in the appropriate fiscal year.

Administrative costs are required to cover 1 additional position to support the permanent POD position, IT data system modifications, increased cost for the POD contracted services, and other related administrative costs.

The current POD contract would need to be competitively re-procured for the appropriate level of services expected, as a \$12 million increase in POD subsidies administered would be a significant change to the contract service specifications.

Also, expanding the eligibility requirements for the POD program will require amendments to the existing Hawaii Administrative Rules (HAR) Chapter 17-799, adopted pursuant to Chapter 91, Hawaii Revised Statutes (HRS).

5. Provision of necessary administrative resources for DHS – staffing.

Staffing support required to make simultaneous changes for the POD program to administrative rules, operational procedures, IT data system modifications, and reprocurement of the POD contracted service is greater than the current staffing level of the DHS Child Care Program Office (CCPO).

CCPO is in the process of implementing significant changes to both the DHS child care licensing and federally funded child care subsidy programs, as required by the Child Care and Development Block Grant (CCDBG) Act of 2014, Public Law 113-186, and 45 Code of Federal Regulations Part 98. Compliance is required for Hawaii to continue to receive approximately \$22 million in federal Child Care and Development Fund (CCDF) grants from the U.S. Department of Health and Human Services' Administration for Children and Families.

The CCDBG Act of 2014 reauthorized the CCDF program and made expansive changes focused on protecting the health and safety of children in care, making the program more family-friendly by streamlining child care subsidy eligibility policies, ensuring parents and the general public have transparent information about the child care choices available to them, and improving the overall quality of early learning and afterschool programs. The deadline for DHS to complete all of the required changes for the federal CCDF grants is September 30, 2018.

6. DHS requests an effective date of July 1, 2018 or later.

The statutory changes being considered, will require changes to administrative rules and operations, all while DHS implements the current program and moves the state into compliance with requirements of the CCDBG Act described above.

POD is currently accepting applications until March 31, 2017 for services in the 2017-2018 POD year. If either HB 388 or HB 578 (or companion measures: SB 181 and SB 497) were to pass as drafted with the Legislature's expectation of implementation effective FY 2018, given the current program demands and compliance efforts, DHS would be unable to modify the required IT data system, program eligibility, and administrative rule changes effective July 1, 2017. DHS respectfully requests a one year (or more) delay to the effective date to give DHS time to complete the necessary administrative and operational changes needed to change the POD eligibility requirements and delivery systems.

On behalf of Hawaii Children's Action Network (HCAN), we are writing to support the intent of HB 578 – Relating to Preschool Open Doors Program

HCAN supports the intention to expand the Preschool Open Doors program to children younger than 4 years old. When Preschool Open Doors started in 1990, this state-funded program served 3 & 4 year olds from qualifying low-income families. However, the program was significantly reduced in 2012 and 2013. Although services and funding for the program increased in the last year, the program has not been restored to the needed service levels.

Hawaii ranks second to last out of the most affordable states in the nation. Childcare is generally the second largest expense in family budgets after housing cost, averaging about \$8,040 per year. For children under two years that cost is generally much higher. The average POD subsidy is \$540/month to families with a median annual income of \$33,000 in 2015.

As of February 1, 2016, 2,213 applications were received for the Preschool Open Doors program, which provides subsidies for tuition assistance for families earning up to 142% over poverty line. As of the same date, only 1,156 children were being served. This is an opportunity to improve the chances for Hawaii's children to succeed by increasing the reach of the program.

By expanding the age range, it will provide more low- to moderate-income parents, especially single parents, the opportunity to pursue higher education, training, or work as well as better prepare students to succeed in school. Preschool Open Doors promotes cognitive, social, and emotional development of young children and school readiness in our state, where only 14.5% of children display comprehensive readiness for kindergarten.

HCAN is committed to building a unified voice advocating for Hawaii's children by improving their safety, health, and education. Last fall, HCAN convened input in person and online from more than 50 organizations and individuals that came forward to support or express interest for a number of issues affecting children and families in our state that resulted in the compilation of 2017 Hawai'i Children's Policy Agenda, which can be accessed at http://www.hawaii-can.org/2017policyagenda.

Since this bill does not contain any increased funding for the program while increasing the services, we are support the intent, but cannot support the passage.

For these reasons, HCAN respectfully requests that the committee vote to combine this bill with HB 388.
